- AN ACT to amend chapter 58 of the laws of 2005, relating to authorizing reimbursements for expenditures made by or on behalf of social services districts for medical assistance for needy persons and the administration thereof, and to amend the general municipal law, in relation to calculating social services district medical assistance expenditure amounts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision (c-1) of section 1 of part C of chapter 58 of the laws of 2005, relating to authorizing reimbursements for expenditures made by or on behalf of social services districts for medical assistance for needy persons and the administration thereof, as added by section 1 of part F of chapter 56 of the laws of 2012, is amended to read as follows:

7 (c-1) Notwithstanding any provisions of subdivision (c) of this 8 section to the contrary, effective April 1, 2013, for the period January 9 1, 2013 through December 31, 2013 and for each calendar year thereafter, 10 the medical assistance expenditure amount for the social services 11 district for such period shall be [equal to] the GREATER OF (I) ZERO; OR 12 (II) THE previous calendar year's medical assistance expenditure amount
