AN ACT authorizing the county of Suffolk to alienate certain parcels of land used as parkland and to acquire other parcels of land to replace such parkland

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subject to the provisions of this act, the county of
2 Suffolk, acting by and through its governing body, is hereby authorized
3 to discontinue as parklands and alienate the lands more particularly
4 described in section three of this act, and to sell and convey such
5 parklands at fair market value and upon such other terms and conditions
6 as determined by the governing body of Suffolk County to the Elwood
7 Public Library.
8 S 2. The authorization contained in section one of this act shall take
9 effect only upon the condition that the county of Suffolk shall acquire
10 and dedicate the lands described in section four of this act as addi-
11 tional parklands of the county.
12 S 3. The lands authorized by section one of this act to be discontin-
13 ued as parklands and conveyed to the Elwood Public Library consist of
14 1.2 acres and are described as follows:
15 BEGINNING at a point on the westerly side of Cuba Hill Road distant,
16 187.00 Feet southerly as measured along the westerly side of Cuba Hill
17 Road from the extreme southerly end of the arc of a curve which connects
18 the southerly side of Elbormar Drive with the westerly side of Cuba Hill
19 Road.

20 shall dedicate the replacement lands for use as parkland for public park
21 purposes consisting of 44.38 acres described as follows:
22 All that certain plot, piece or parcel of land, with the buildings and
23 improvements thereon erected, situate, lying and being at Mt. Sinai,
24 Town of Brookhaven, County of Suffolk and State of New York being more
25 particularly bounded and described as follows:
26 BEGINNING at a monument on the southerly side of Bayview Avenue (Old
27 Post Lane) where the same is intersected by the easterly line of lands
28 of the order of Poor Brethren of St. Francis, now known as the Society
29 of St. Francis, American Province, Inc. and the westerly side of the
30 premises herein described;

5 S 5. In the event that the parklands to be dedicated by the county of
6 Suffolk pursuant to this act are not equal to or greater than the fair
7 market value of the parkland to be discontinued and conveyed, the county
8 of Suffolk shall dedicate the difference of the fair market value of the
9 lands to be alienated and the lands to be dedicated for the acquisition
10 of additional parklands and/or for capital improvements to existing park
11 and recreational facilities.

12 S 6. In the event that the county of Suffolk received any funding
13 support or assistance from the federal government for the purchase,
14 maintenance or improvement of the parklands set forth in section three
15 of this act, the discontinuance and alienation of such parkland author-
16 ized by the provisions of this act shall not occur until the county of
17 Suffolk has complied with any federal requirements pertaining to the
18 alienation or conversion of such parklands, including satisfying the
19 secretary of the interior that the alienation or conversion complies
20 with all conditions which the secretary of the interior deems necessary
21 to assure the substitution of other lands shall be equivalent in fair
22 market value and usefulness to the lands being alienated or converted.

23 S 7. This act shall take effect immediately.
