AN ACT to amend the agriculture and markets law, in relation to creating a horizontal silo leachate runoff working group

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The agriculture and markets law is amended by adding a new article 13-F to read as follows:

ARTICLE 13-F

- WORKING GROUP SHALL MEET REGULARLY AND SHALL REVIEW AND STUDY 3. THETHE OPTIONS AND BEST PRACTICES THAT ARE AVAILABLE, INCLUDING THOSE STATES, FOR THE TREATMENT AND MANAGEMENT OF LEACHATE RUNOFF FROM HORIZONTAL OR BUNKER SILOS. THE WORKING GROUP SHALL INCLUDE IN THEIR DISCUSSION, BUT NOT LIMIT IT TO, THE COST OF SUCH TREATMENT AND MANAGE-MENT OPTIONS FOR THE LEACHATE RUNOFF FROM HORIZONTAL OR BUNKER GROUP SHALL ALSO INCLUDE IN THEIR DISCUSSION, BUT NOT LIMIT IT TO,

MANAGEMENT OF LEACHATE RUNOFF FROM HORIZONTAL OR BUNKER SILOS. UPON THE CONCLUSION OF THEIR STUDY, THE WORKING GROUP SHALL PUBLISH A REPORT, THAT IS WIDELY AVAILABLE, WHICH OUTLINES THE FINDINGS OF THE WORKING GROUP. THE REPORT SHALL BE SENT TO THE UNITED STATES DEPARTMENT OF AGRICULTURE NATURAL RESOURCE CONSERVATION SERVICE FOR THEIR REVIEW.

- 4. IF THE NEED EXISTS, THE WORKING GROUP MAY CONTINUE TO EXIST AFTER THE PUBLICATION OF THEIR FINDINGS TO ADDRESS OTHER RELEVANT ISSUES WITH-IN THEIR COMPETENCY.
- S 2. This act shall take effect immediately.
