- AN ACT to amend the executive law, in relation to requiring counties to maintain a confidential registry of people of all ages with disabilities for evacuation and sheltering during disasters

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 23-a of the executive law, as added by chapter 658 2 of the laws of 1996, is amended to read as follows:

[County] CONFIDENTIAL COUNTY registry of [disabled persons] PEOPLE OF ALL AGES WITH DISABILITIES, AS THAT TERM IS DEFINED IN SUBDI-4 5 VISION TWENTY-ONE OF SECTION TWO HUNDRED NINETY-TWO OF THIS CHAPTER; 6 each county having a local [disaster preparedness] notice. 1. In 7 COMPREHENSIVE EMERGENCY MANAGEMENT plan pursuant to section twenty-three 8 of this article, in order to meet the special needs of persons OF ALL 9 AGES WITH DISABILITIES who would need assistance during evacuations and 10 sheltering because of physical or mental [handicaps] DISABILITIES, it [is recommended] SHALL BE REQUIRED that each chief executive maintain a 11 12 CONFIDENTIAL registry of [disabled persons] PEOPLE OF ALL AGES WITH 13 DISABILITIES located within the county. The chief executive shall, upon [the] request [of the state 16 emergency management office], provide such registry information to STATE EMERGENCY MANAGEMENT office, PROVIDED THAT THE CONFI-17 [such] THE DENTIALITY OF SUCH INFORMATION IS PRESERVED. The chief executive 18 may, 19 his OR HER discretion, use the registry information for local disasat 20 ter preparedness [only] in coordination with other political subdivi-21 sions of the state, PROVIDED THAT THE CONFIDENTIALITY OF SUCH INFORMA-22 TION IS PRESERVED.

23 Upon the establishment of a [voluntary] CONFIDENTIAL registry of 3. 24 [disabled persons] PEOPLE OF ALL AGES WITH DISABILITIES as provided in 25 subdivision one of this section, [at least semi-annually,] each chief 26 executive shall ANNUALLY cause to be published in a newspaper of general circulation within the county a notice of the availability of the [voluntary] registration program AND EACH CHIEF EXECUTIVE SHALL, IN HIS 27 28 29 HER DISCRETION, ALSO PROVIDE INFORMATION ABOUT THE REGISTRY AND THE OR REGISTRATION PROCESS TO OTHER FORMS OF MEDIA, AND SHALL FURTHER 30 ENSURE INFORMATION ABOUT THE REGISTRY AND THE REGISTRATION PROCESS IS 31 THAT 32 AVAILABLE ON THE WEBSITE OF SUCH COUNTY.

33 4. All records, data, information, correspondence and communications relating to the registration of [disabled persons] PEOPLE OF ALL AGES 34 35 WITH DISABILITIES as provided in subdivision one of this section are confidential, except that such information shall be available to other 36 37 county chief executives for local disaster preparedness only as the 38 chief executive of the county maintaining such registry deems necessary. 39 Provided, however, the individual file of a person having registered 40 with the CONFIDENTIAL registry of [disabled persons] PEOPLE OF ALL AGES WITH DISABILITIES shall be made available to that person upon request. 41

All community-based services providers, including home health care 42 5. 43 providers, shall assist the chief executive by collecting CONFIDENTIAL 44 registration information for people [with special needs] OF ALL AGES 45 WITH DISABILITIES WHO CHOOSE TO PROVIDE SUCH INFORMATION as part of program intake processes, establishing programs to increase the aware-46 47 ness of the registration process, and educating [clients] CONSUMERS 48 about the procedures that may be necessary for their safety during 49 disasters.

50 6. A county shall not be liable for any claim based upon the REASON-51 ABLE, good faith exercise or performance or the REASONABLE, good faith 52 failure to exercise or perform a function or duty on the part of any 53 officer or employee in carrying out a local disaster preparedness plan. 54 S 2. This act shall take effect on the first of January next succeed-55 ing the date on which it shall have become a law.
