AN ACT to amend the education law, in relation to certain service learning, internship, or independent study programs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 355 of the education law is amended by adding a new 2 subdivision 20 to read as follows:

3 20. THE STATE UNIVERSITY TRUSTEES SHALL ADOPT REGULATIONS TO ESTABLISH LEARNING, INTERNSHIP, OR INDEPENDENT STUDY PROGRAM FOR SERVICE 5 AND/OR STUDENTS THAT SERVE AS ACTIVE VOLUNTEER FIREFIGHTERS VOLUNTEER AMBULANCE WORKERS. EACH STATE-OPERATED INSTITUTION AND COMMU-NITY COLLEGE MAY, AS DETERMINED BY ITS PRESIDENT, OFFER SUCH A 7 8 INTERNSHIP, OR INDEPENDENT STUDY PROGRAM TO ELIGIBLE STUDENTS LEARNING, 9 IN ACCORDANCE WITH THE REGULATIONS PRESCRIBED BY THE STATE UNIVERSITY 10 TRUSTEES. SUCH PROGRAM SHALL CONSIST OF (A) A COMMUNITY SERVICE COMPO-NENT THAT MAY BE COMPLETED THROUGH NO LESS THAN TWENTY HOURS OF VERIFI-11 ABLE VOLUNTEER FIREFIGHTING ACTIVITIES, VOLUNTEER AMBULANCE OR EMERGENCY 12 ACTIVITIES, OR OTHER ACTIVITIES RELATED TO VOLUNTEER FIRE OR 13 14 AMBULANCE SERVICE AS DETERMINED BY THE STATE UNIVERSITY TRUSTEES, (B) AN ACADEMIC COMPONENT RELATED TO SUCH VOLUNTEER ACTIVITY THAT MAY BE 15 16 COMPLETED THROUGH A WRITTEN REPORT OR JOURNAL, OR OTHER WRITTEN ASSIGN-17 MENT AS DETERMINED BY THE STATE UNIVERSITY TRUSTEES. SUCH PROGRAM SHALL OPEN TO ANY STUDENT ENROLLED IN AN ASSOCIATE OR BACCALAUREATE 18 19 DEGREE-PRODUCING PROGRAM ON A FULL-TIME OR PART-TIME BASIS THAT IS 20 FIREFIGHTER AS DEFINED IN SUBDIVISION ONE OF SECTION VOLUNTEER 21 TWO HUNDRED FIFTEEN OF THE GENERAL MUNICIPAL LAW OR AN ACTIVE VOLUNTEER 22 DEFINED IN SUBDIVISION FOURTEEN OF SECTION TWO AMBULANCE WORKER AS 23 HUNDRED NINETEEN-K OF THE GENERAL MUNICIPAL LAW. NO MORE THAN 24 ACADEMIC CREDITS SHALL BE AWARDED TO A STUDENT FOR SUCCESSFUL COMPLETION 25 SUCH SERVICE LEARNING, INTERNSHIP OR INDEPENDENT STUDY PROGRAM. IN

DEVELOPING THE SERVICE LEARNING, INTERNSHIP OR INDEPENDENT STUDY PROGRAM DESCRIBED IN THIS SUBDIVISION, THE STATE UNIVERSITY TRUSTEES MAY, IN ITS DISCRETION, CONSULT WITH THE NEW YORK STATE OFFICE OF FIRE PREVENTION AND CONTROL AND/OR ANY STATEWIDE ORGANIZATION THAT REPRESENTS THE INTER-ESTS OF THE VOLUNTEER FIRE SERVICE OR THE VOLUNTEER AMBULANCE SERVICE.

S 2. This act shall take effect on the ninetieth day after it shall have become a law; provided however that, effective immediately, state university trustees are authorized and directed to add, amend and/or repeal any rule or regulation necessary for the implementation of this act on its effective date.
