



1 (A) THE LEGAL NAME AND ANY OTHER NAMES OR ALIASES THAT THE ANIMAL  
2 ABUSER IS USING OR HAS USED;  
3 (B) THE DATE OF BIRTH OF THE ANIMAL ABUSER;  
4 (C) THE SOCIAL SECURITY NUMBER OF THE ANIMAL ABUSER;  
5 (D) THE CURRENT ADDRESS OR LOCATION OF THE ANIMAL ABUSER;  
6 (E) THE PLACE OF EMPLOYMENT OF THE ANIMAL ABUSER;  
7 (F) THE OFFENSE FOR WHICH THE ANIMAL ABUSER WAS CONVICTED; AND  
8 (G) THE DATE AND PLACE OF THE ANIMAL PROTECTION OFFENSE CONVICTION OF  
9 THE ANIMAL ABUSER.

10 4. WHEN AN ANIMAL ABUSER REGISTERS WITH A COUNTY SHERIFF, THE SHERIFF  
11 SHALL OBTAIN:

12 (A) A PHOTOGRAPH OF THE ANIMAL ABUSER AND A COMPLETE SET OF THE ANIMAL  
13 ABUSER'S FINGERPRINTS; AND

14 (B) A DESCRIPTION OF ANY TATTOOS, SCARS OR OTHER DISTINGUISHING  
15 FEATURES ON THE ANIMAL ABUSER'S BODY THAT WOULD ASSIST IN IDENTIFYING  
16 THE ANIMAL ABUSER.

17 5. FOLLOWING AN ANIMAL ABUSER'S INITIAL REGISTRATION PURSUANT TO THE  
18 PROVISIONS OF THIS SECTION, AN ANIMAL ABUSER SHALL ANNUALLY RENEW THE  
19 ANIMAL ABUSER'S REGISTRATION WITH THE COUNTY SHERIFF PRIOR TO DECEMBER  
20 THIRTY-FIRST OF EACH SUBSEQUENT CALENDAR YEAR FOR A PERIOD OF FIFTEEN  
21 YEARS.

22 6. AN ANIMAL ABUSER WHO INTENTIONALLY OR KNOWINGLY FAILS TO COMPLY  
23 WITH THE REGISTRATION REQUIREMENTS, OR PROVIDES FALSE INFORMATION WHEN  
24 COMPLYING WITH THE REGISTRATION REQUIREMENTS SET FORTH IN THIS SECTION,  
25 IS GUILTY OF A CLASS E FELONY. EACH COUNTY SHERIFF SHALL MAINTAIN A  
26 LOCAL REGISTRY OF ANIMAL ABUSERS IN THE SHERIFF'S JURISDICTION REQUIRED  
27 TO REGISTER PURSUANT TO THIS SECTION.

28 7. THE COUNTY SHERIFF SHALL FORWARD ALL REGISTRATION INFORMATION  
29 OBTAINED FROM ANIMAL ABUSERS TO THE DIVISION OF CRIMINAL JUSTICE  
30 SERVICES.

31 8. WITHIN TEN DAYS OF RECEIVING INITIAL REGISTRATION INFORMATION FROM  
32 AN ANIMAL ABUSER, THE COUNTY SHERIFF SHALL CONTACT EVERY RESIDENCE,  
33 SCHOOL, HUMANE SOCIETY, ANIMAL SHELTER AND ANY OTHER BUSINESS WITHIN A  
34 HALF MILE RADIUS OF THE ANIMAL ABUSER'S RESIDENCE OR LOCATION AND  
35 PROVIDE THEM WITH THE ANIMAL ABUSER'S REGISTRATION INFORMATION, WITH THE  
36 EXCEPTION OF THE ANIMAL ABUSER'S SOCIAL SECURITY NUMBER.

37 9. THE DIVISION OF CRIMINAL JUSTICE SERVICES SHALL MAINTAIN A CENTRAL  
38 REGISTRY OF ANIMAL ABUSERS REQUIRED TO REGISTER PURSUANT TO THE  
39 PROVISIONS OF THIS SECTION. THE CENTRAL REGISTRY OF ANIMAL ABUSERS SHALL  
40 BE MADE AVAILABLE TO THE PUBLIC VIA INTERNET AND IN WRITTEN FORM UPON  
41 WRITTEN OR VERBAL REQUEST. ALL OF THE INFORMATION CONTAINED IN AN ANIMAL  
42 ABUSER'S REGISTRATION, WITH THE EXCEPTION OF THE ANIMAL ABUSER'S SOCIAL  
43 SECURITY NUMBER, SHALL BE MADE AVAILABLE. RECORDS OF EACH ANIMAL  
44 ABUSER'S REGISTRATION SHALL BE MAINTAINED FOR THE DURATION OF THE  
45 FIFTEEN YEAR PERIOD IN WHICH THE ANIMAL ABUSER IS REQUIRED TO BE REGIS-  
46 TERED.

47 S 423. SEPARABILITY. IF ANY SECTION OF THIS ARTICLE, OR PART THEREOF  
48 SHALL BE ADJUDGED BY A COURT OF COMPETENT JURISDICTION TO BE INVALID,  
49 SUCH JUDGMENT SHALL NOT AFFECT, IMPAIR OR INVALIDATE THE REMAINDER OR  
50 ANY OTHER SECTION OR PART THEREOF.

51 S 2. This act shall take effect on the ninetieth day after it shall  
52 have become a law.
