- AN ACT to amend the arts and cultural affairs law, in relation to prohibiting the New York state council on the arts from awarding arts and cultural grants when an organization has no place of business within the state and does not apply awarded monies to New York state programs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The arts and cultural affairs law is amended by adding a 2 new section 3.19 to read as follows:

3 S 3.19. PROHIBITION. THE COUNCIL ON THE ARTS SHALL BE PROHIBITED FROM 4 ISSUING GRANTS TO AN ORGANIZATION UNLESS SUCH ORGANIZATION IS INCORPO-5 AS A NONPROFIT ORGANIZATION EITHER IN THE STATE OR, IF AN ORGAN-RATED 6 IZATION IS INCORPORATED ELSEWHERE, SUCH ORGANIZATION MUST BE REGISTERED 7 IN THE STATE THROUGH THE DEPARTMENT OF STATE AND MUST DO BUSINESS TO 8 HAVE ITS PRINCIPAL PLACE OF BUSINESS LOCATED WITHIN THE STATE. GRANT 9 RECIPIENTS SHALL ALSO BE PROHIBITED FROM USING GRANT FUNDING RECEIVED FROM THE COUNCIL ON THE ARTS TO FUND COMPONENTS OF AN ORGANIZATION'S 10 11 BUDGET THAT ARE NOT DIRECTED TOWARDS PROGRAMS IN THE STATE. IF AN ORGANIZATION IS FOUND TO HAVE VIOLATED THIS SECTION, THEY SHALL (1) 12 ΒE REIMBURSE BACK TO COUNCIL ON THE ARTS, ALL MONIES 13 REOUIRED TO THE RECEIVED UNDER THE PARTICULAR GRANT WITHIN THIRTY DAYS OR FACE A FINE TO 14 BE DETERMINED BY THE DEPARTMENT OF STATE, AND (2) NOT BE ALLOWED 15 ТО 16 REAPPLY FOR FUTURE FUNDING UNTIL THEY PROVIDE PROOF TO THE COUNCIL ON

1 THE ARTS OF THEIR SUBSEQUENT FILING OF ARTICLES OF INCORPORATION WITH 2 THE DEPARTMENT OF STATE IN NEW YORK.

3 S 2. This act shall take effect immediately; provided, however, that 4 this act shall apply only to grants issued on or after the effective 5 date of this act that are not subject to contracts entered into by the 6 council on the arts to provide grants which contracts were executed 7 prior to the effective date of this act.
