- Introduced by M. of A. ROBINSON, CLARK, PAULIN, SCARBOROUGH, TITUS, McDONOUGH -- read once and referred to the Committee on Children and Families
- AN ACT to amend the family court act, in relation to warrants and orders of protection in persons in need of supervision cases

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions (g) and (h) of section 735 of the family court 2 act, as added by section 7 of part E of chapter 57 of the laws of 2005, 3 are amended to read as follows:

4 (i) The designated lead agency shall promptly give written notice (q) 5 to the potential petitioner whenever attempts to prevent the filing of a б petition have terminated, and shall indicate in such notice whether 7 efforts were successful. The notice shall also detail the diligent 8 attempts made to divert the case if a determination has been made that 9 there is no substantial likelihood that the youth will benefit from further attempts. No persons in need of supervision petition may be 10 11 filed pursuant to this article during the period the designated lead agency is providing diversion services. A finding by the designated lead 12 agency that the case has been successfully diverted shall constitute 13 presumptive evidence that the underlying allegations have been success-14 fully resolved in any petition based upon the same factual allegations. 15 16 No petition may be filed pursuant to this article by the parent or other 17 person legally responsible for the youth where diversion services have been terminated because of the failure of the parent or other person 18 19 legally responsible for the youth to consent to or actively participate. (ii) [The] EXCEPT AS PROVIDED IN PARAGRAPH (III) OF THIS SUBDIVISION, 20 THE clerk of the court shall accept a petition for filing only if it has 21 22 attached thereto the following NOTICES:

23 (A) if the potential petitioner is the parent or other person legally 24 responsible for the youth, a notice from the designated lead agency

1 indicating there is no bar to the filing of the petition as the poten-2 tial petitioner consented to and actively participated in diversion 3 services; and

4 (B) a notice from the designated lead agency stating that it has 5 terminated diversion services because it has determined that there is no 6 substantial likelihood that the youth and his or her family will benefit 7 from further attempts, and that the case has not been successfully 8 diverted.

(III) THE CLERK OF THE COURT SHALL ACCEPT A PETITION FOR FILING IF:

10 POTENTIAL PETITIONER IS REQUESTING THAT THE COURT ISSUE A (A) THE WARRANT PURSUANT TO SECTION SEVEN HUNDRED THIRTY-EIGHT OF THIS 11 ARTICLE, RESPONDENT HAS ABSCONDED FROM THE HOME AND IS UNABLE TO BE 12 BECAUSE THELOCATED AND THE POTENTIAL PETITIONER HAS MET WITH THE 13 DESIGNATED LEAD 14 AGENCY WHICH MUST MAKE EFFORTS TO LOCATE THE CHILD AND THOSE EFFORTS BY 15 THE DESIGNATED LEAD AGENCY HAVE NOT LOCATED THE CHILD; OR

16 (B) THE POTENTIAL PETITIONER IS REQUESTING THAT THE COURT ISSUE A 17 TEMPORARY ORDER OF PROTECTION, PURSUANT TO SECTION SEVEN HUNDRED FORTY 18 OF THIS ARTICLE, BECAUSE THE RESPONDENT POSES AN IMMINENT RISK OF HARM 19 TO THE POTENTIAL PETITIONER OR MEMBER OF HIS OR HER HOUSEHOLD.

29 S 2. Subdivision (b) of section 742 of the family court act, as 30 amended by section 9 of part E of chapter 57 of the laws of 2005, is 31 amended to read as follows:

32 At the initial appearance of the respondent, the court shall (b) 33 review any termination of diversion services pursuant to such section, 34 and the documentation of diligent attempts to provide appropriate services and determine whether such efforts or services provided 35 are sufficient [and]. THE COURT may, AT ANY TIME, subject to the provisions 36 37 of section seven hundred forty-eight of this article, order that additional diversion attempts be undertaken by the designated lead agency. 38 39 The court may order the youth and the parent or other person legally 40 responsible for the youth to participate in diversion services. AT THE INITIAL APPEARANCE OF THE RESPONDENT ON A PETITION FILED IN ACCORDANCE 41 WITH SUBPARAGRAPH (A) OF PARAGRAPH (III) OF SUBDIVISION (G) OF SECTION 42 SEVEN HUNDRED THIRTY-FIVE OF THIS ARTICLE, THE COURT 43 SHALL REFER THE 44 RESPONDENT AND PARENT ΤO THE DESIGNATED LEAD AGENCY FOR DIVERSION 45 ATTEMPTS, UNLESS THE COURT DETERMINES THAT THERE IS A SUBSTANTIAL LIKE-46 LIHOOD THAT THE CHILD WOULD ABSCOND OR THERE IS NO SUBSTANTIAL LIKELI-47 HOOD THAT THE YOUTH AND HIS OR HER FAMILY WOULD BENEFIT FROM DIVERSION 48 ATTEMPTS.
