AN ACT to amend chapter 332 of the laws of 2014 relating to authorizing  
the city of Lockport, in the county of Niagara, to finance a certain  
deficit by the issuance of bonds, in relation to adoption of the budg-  
et by the city of Lockport

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision (c) of section 5 of chapter 332 of the laws of  
2     2014 relating to authorizing the city of Lockport, in the county of  
3     Niagara, to finance a certain deficit by the issuance of bonds, is  
4     amended to read as follows:  
5     (c) For the fiscal year beginning January 1, 2015 and for each fiscal  
6     year thereafter during which such debt or any debt incurred to refund  
7     such debt is outstanding, the mayor of the city of Lockport or other  
8     officer or officers responsible for the preparation of the tentative  
9     budget shall submit the tentative budget for the next succeeding fiscal  
10    year to the state comptroller no later than thirty days before the last  
11    date on which the budget must be finally adopted. The state comptroller  
12    shall examine such proposed budget and make such recommendations as  
13    deemed appropriate thereon to the common council of the city of Lockport  
14    no later than ten days before the last date on which the budget must be  
15    finally adopted. Such recommendations shall be made after examination  
16    into the estimates of revenues and expenditures of the city of Lockport.  
17    The common council of the city of Lockport, no later than five days  
18    prior to the adoption of the budget, shall review any such recommenda-  
19    tions and [may] make adjustments to its proposed budget consistent with  
20    any recommendations made by the state comptroller. [Any recommendations  
21    that the common council rejects shall be explained in writing to the  
22    state comptroller.] The action or inaction of the state comptroller  
23    under this section shall not be construed to affect the legal validity

1 of the budget of the city of Lockport nor to affect the powers or duties  
2 of the city of Lockport with respect to the local budget; provided,  
3 however, that the city of Lockport may not issue bonds for any object or  
4 purpose unless and until adjustments to its proposed budget, consistent  
5 with any recommendations made by the state comptroller, are made[, or  
6 any such recommendations that are rejected have been explained in writ-  
7 ing to the state comptroller].  
8 S 2. This act shall take effect immediately and shall be deemed to  
9 have been in full force and effect on and after the date chapter 332 of  
10 the laws of 2014 took effect.
