Introduced by M. of A. PEOPLES-STOKES -- read once and referred to the Committee on Ways and Means

AN ACT to amend chapter 58 of the laws of 2005, relating to authorizing reimbursements for expenditures made by or on behalf of social services districts for medical assistance for needy persons and the administration thereof, in relation to a five year elimination of the local share for medicaid

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (iv) of subdivision (c) of section 1 of part C of chapter 58 of the laws of 2005, relating to authorizing reimbursements for expenditures made by or on behalf of social services districts for medical assistance for needy persons, is amended and seven new subdivisions (c-2), (c-3), (c-4), (c-5), (c-6), (c-7) and (c-8) are added to read as follows:

7 (iv) 2009 (January 1, 2009 through December 31, 2009), and each 8 succeeding calendar year THROUGH 2017: prior year's trend factor 9 percentage plus 3%.

NO LESS 15 THAN 75% OF THE SAVINGS FROM THIS MEDICAL ASSISTANCE EXPENDITURE 16 REDUCTION SHALL BE USED FOR PROPERTY TAX LEVY REDUCTIONS, OR PROPERTY TAX REBATES, EFFECTIVE IN THE LOCAL GOVERNMENT'S 2019 FISCAL YEAR. 17

18 (C-3) NOTWITHSTANDING THE PROVISIONS OF SECTION 368-A OF THE SOCIAL
19 SERVICES LAW, OR ANY OTHER PROVISION OF LAW, COMMENCING WITH THE PERIOD
20 JANUARY 1, 2019 THROUGH DECEMBER 31, 2019, CALENDAR YEAR SOCIAL SERVICES
21 DISTRICT MEDICAL ASSISTANCE EXPENDITURE AMOUNTS FOR EACH SOCIAL SERVICES
22 DISTRICT SHALL BE REDUCED BY 40% FROM THE 2017 EXPENDITURES. NO LESS

5 (C-4) NOTWITHSTANDING THE PROVISIONS OF SECTION 368-A OF THE SOCIAL 6 SERVICES LAW, OR ANY OTHER PROVISION OF LAW, COMMENCING WITH THE PERIOD 7 JANUARY 1, 2020 THROUGH DECEMBER 31, 2020, CALENDAR YEAR SOCIAL SERVICES 8 DISTRICT MEDICAL ASSISTANCE EXPENDITURE AMOUNTS FOR EACH SOCIAL SERVICES DISTRICT SHALL BE REDUCED BY 60% FROM THE 2017 EXPENDITURES. NO LESS 9 10 THAN 75% OF THE ANNUAL SAVINGS FROM THIS MEDICAL ASSISTANCE EXPENDITURE 11 REDUCTION, COMPARED TO THE PRIOR YEAR MEDICAL ASSISTANCE EXPENDITURE, SHALL BE USED FOR PROPERTY TAX LEVY REDUCTIONS, OR PROPERTY TAX REBATES, 12 EFFECTIVE IN THE LOCAL GOVERNMENT'S 2021 FISCAL YEAR. 13

14 (C-5) NOTWITHSTANDING THE PROVISIONS OF SECTION 368-A OF THE SOCIAL SERVICES LAW, OR ANY OTHER PROVISION OF LAW, COMMENCING WITH THE PERIOD 15 16 JANUARY 1, 2021 THROUGH DECEMBER 31, 2021, CALENDAR YEAR SOCIAL SERVICES DISTRICT MEDICAL ASSISTANCE EXPENDITURE AMOUNTS FOR EACH SOCIAL SERVICES 17 DISTRICT SHALL BE REDUCED BY 80% FROM THE 2017 EXPENDITURES. 18 NO LESS 19 THAN 75% OF THE ANNUAL SAVINGS FROM THIS MEDICAL ASSISTANCE EXPENDITURE REDUCTION, COMPARED TO THE PRIOR YEAR MEDICAL ASSISTANCE EXPENDITURE, SHALL BE USED FOR PROPERTY TAX LEVY REDUCTIONS, OR PROPERTY TAX REBATES, 20 21 EFFECTIVE IN THE LOCAL GOVERNMENT'S 2022 FISCAL YEAR. 22

23 (C-6) NOTWITHSTANDING THE PROVISIONS OF SECTION 368-A OF THE SOCIAL SERVICES LAW, OR ANY OTHER PROVISION OF LAW, COMMENCING WITH THE 24 PERIOD 25 JANUARY 1, 2022 THROUGH DECEMBER 31, 2022, CALENDAR YEAR SOCIAL SERVICES 26 DISTRICT MEDICAL ASSISTANCE EXPENDITURE AMOUNTS FOR EACH SOCIAL SERVICES DISTRICT SHALL BE REDUCED BY 100% FROM THE 2017 EXPENDITURES; AND SHALL 27 28 REMAIN ELIMINATED EACH YEAR THEREAFTER. NO LESS THAN 75% OF THE ANNUAL SAVINGS FROM THIS MEDICAL ASSISTANCE EXPENDITURE REDUCTION, COMPARED TO 29 30 THE PRIOR YEAR MEDICAL ASSISTANCE EXPENDITURE, SHALL BE USED FOR PROPER-TY TAX LEVY REDUCTIONS, OR PROPERTY TAX REBATES, EFFECTIVE IN THE LOCAL 31 32 GOVERNMENT'S 2023 FISCAL YEAR.

(C-7) NOTWITHSTANDING THE PROVISIONS OF SECTION SEVEN OF THIS ACT, ANY
COUNTY THAT OPTED INTO THE LOCAL SALES TAX INTERCEPT METHODOLOGY SHALL
RECEIVE A PROPORTIONATE REDUCTION IN THE SALES TAX INTERCEPT AS
DESCRIBED IN SUBDIVISIONS (C-2), (C-3), (C-4), (C-5) AND (C-6) OF THIS
SECTION AND USE THESE RECAPTURED FUNDS FOR PROPERTY TAX REDUCTIONS IN
THE SAME MANNER AS OTHER LOCAL JURISDICTIONS AS DESCRIBED.

39 (C-8) THE MINIMUM AMOUNT OF ANNUAL PROPERTY TAX LEVY REDUCTIONS 40 RESULTING FROM SAVINGS ACHIEVED AS DEFINED IN SUBDIVISIONS (C-2), (C-3), 41 (C-4), (C-5) AND (C-6) OF THIS SECTION, SHALL BE DETERMINED BY THE STATE 42 COMPTROLLER AND TRANSMITTED TO EACH LOCAL GOVERNMENT ONE HUNDRED EIGHTY 43 DAYS IN ADVANCE OF THE START OF THE FISCAL YEAR FOR WHICH THE PROPERTY 44 TAX REDUCTION IS TO BE EFFECTIVE.
