AN ACT to amend the executive law, in relation to the definition of a campground within the Adirondack park

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivision 10 of section 802 of the executive law, as 2 amended by chapter 348 of the laws of 1973, is amended to read as 3 follows:
- 10. "Campground" means [any area designed for transient occupancy by camping in tents, camp trailers, travel trailers, motor homes or similar facility designed for temporary shelter] A TRACT OR PARCEL OF LAND, INCLUDING PRINCIPAL BUILDINGS AND ACCESSORY STRUCTURES, WHERE FIVE OR 7 8 MORE CAMPSITES ARE MADE AVAILABLE FOR TEMPORARY OR SEASONAL OVERNIGHT OCCUPANCY. NOTHING IN THIS ARTICLE SHALL REQUIRE THE REMOVAL OF A RECRE-9 ATIONAL VEHICLE THAT REMAINS ON A CAMPGROUND OR A CAMPSITE IN SUCH CAMP-10 WITH THE CONSENT OF THE OWNER OF THE CAMPGROUND DURING THOSE 11 GROUND, PERIODS OF TIME THAT IT IS NOT OCCUPIED, PROVIDED THAT IT IS NOT USED IN 12 A MANNER THAT VIOLATES THE TERMS AND CONDITIONS OF THE PERMIT ISSUED 13 THE CAMPGROUND BY THE STATE OR A COUNTY DEPARTMENT OF HEALTH. 14
- 15 S 2. Section 802 of the executive law is amended by adding a new 16 subdivision 55-a to read as follows:
- 55-A. "RECREATIONAL VEHICLE" MEANS A VEHICULAR CAMPING UNIT PRIMARILY DESIGNED AS TEMPORARY LIVING QUARTERS FOR RECREATIONAL, CAMPING, TRAVEL OR SEASONAL USE THAT HAS ITS OWN MOTIVE POWER OR IS MOUNTED ON OR TOWED BY ANOTHER VEHICLE.
- 21 S 3. This act shall take effect immediately.
