AN ACT to amend the correction law, in relation to providing inmates with the opportunity to take the test assessing secondary completion

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 136 of the correction law, as amended by chapter 98 of the laws of 2007, is amended to read as follows:

S 136. Correctional education. 1. The objective of correctional educa-3 tion in its broadest sense should be the socialization of the inmates 5 through varied impressional and expressional activities, with emphasis on individual inmate needs. The objective of this program shall be the 7 return of these inmates to society with a more wholesome attitude toward living, with a desire to conduct themselves as good citizens, and with 9 the skill and knowledge which will give them a reasonable chance to maintain themselves and their dependents through honest labor. To this 10 end each inmate shall be given a program of education which, 11 12 basis of available data, seems most likely to further the process of 13 socialization and rehabilitation. Provided that, the commissioner, in 14 consultation with the commissioner of education, shall develop a curric-15 ula for and require provision of an education program to all inmates, on a periodic basis, on the consequences and prevention of shaken baby 16 syndrome which may include the viewing of a video presentation thereon. 17 18 The time daily devoted to such education shall be such as is required 19 for meeting the above objectives. commissioner of education, shall develop the curricula and the education programs that are required to meet the special needs of each correctional facility in the department. The commissioner of education, in [co-operation] COOPERATION with the commissioner and the director of educa-5 tion, shall set up the educational requirements for the certification of teachers in all such correctional facilities. Such educational require-7 ments shall be sufficiently broad and comprehensive to include training in penology, sociology, psychology, philosophy, in the special subjects 8 be taught, and in any other professional courses as may be deemed 9 10 necessary by the responsible officers, and shall include training relating to the consequences and prevention of shaken baby syndrome which may 11 12 include the viewing of a video presentation thereon. No certificates for teaching service in the state institutions shall be issued unless a 13 14 minimum of four years of training beyond the high school has been 15 secured, or an acceptable equivalent. Existing requirements for the 16 certification of teachers in the institutions shall continue in force 17 until changed pursuant to the provisions of this section. 18

- 2. ALL INMATES ADMITTED TO THE DEPARTMENT SERVING A DETERMINATE OF IMPRISONMENT, OR AN INDETERMINATE SENTENCE OF IMPRISONMENT OTHER THAN SENTENCE OF LIFE IMPRISONMENT WITHOUT PAROLE, WHO HAVE BEEN EVALUATED UPON ADMISSION PURSUANT TO SUBDIVISION ONE OF SECTION ONE HUNDRED TY-SEVEN OF THIS ARTICLE AND ARE DETERMINED TO BE CAPABLE OF SUCCESSFUL-COMPLETING THE ACADEMIC COURSE WORK REQUIRED FOR THE TEST ASSESSING SECONDARY COMPLETION, SHALL BE PROVIDED WITH THE OPPORTUNITY TO COMPLETE SUCH COURSE WORK AT LEAST TWO MONTHS PRIOR TO THE DATE onWHICH MAY BE PAROLED, CONDITIONALLY RELEASED, RELEASED TO POST-RELEASE SUPERVISION PURSUANT TO SECTION 70.40 OF THE PENAL LAW, OR PRESUMPTIVELY RELEASED, PURSUANT TO SECTION EIGHT HUNDRED THREE OF THIS CHAPTER. ADMISSION TO THE DEPARTMENT, SUCH INMATES WILL BE PROVIDED WITH WRITTEN NOTICE THAT THE TEST ASSESSING SECONDARY COMPLETION PROGRAMS ARE AVAIL-ABLE FOR ALL INMATES WHO SO APPLY.
- THE DEPARTMENT SHALL ENSURE THAT ACADEMIC EDUCATION PROGRAMS WHICH PROVIDE THE APPROPRIATE CURRICULUM AND CERTIFIED ACADEMIC STAFF FOR TEST ASSESSING SECONDARY COMPLETION INSTRUCTION ARE AVAILABLE AT ALL CORRECTIONAL FACILITIES HOUSING INMATES WHO ARE ELIGIBLE AS SPECIFIED IN SUBDIVISION TWO OF THIS SECTION. THE DEPARTMENT SHALL PROVIDE WHO ARE QUALIFIED TO PROVIDE SUCH INSTRUCTION AND WHO ARE MEMBERS OF THE COMPETITIVE CLASS OF THE CIVIL SERVICE OF NEW YORK STATE. THE DEPARTMENT SHALL DEVELOP A PLAN FOR IMPLEMENTATION OF THE TEST ASSESSING SECONDARY COMPLETION REQUIREMENT WHICH SHALL BE PRESENTED TO THE ASSEM-BLY STANDING COMMITTEE ON CORRECTION AND THE SENATE STANDING COMMITTEE VICTIMS, CRIME AND CORRECTION ON OR BEFORE APRIL FIRST, TWO CRIME THOUSAND NINETEEN.
- S 2. This act shall take effect three years after it shall have become a law; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.
