AN ACT to amend the public health law, the vehicle and traffic law and the state finance law, in relation to establishing the save our sight program and the save our sight fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The public health law is amended by adding a new section 25 2 to read as follows:

- S 25. SAVE OUR SIGHT PROGRAM. THE COMMISSIONER, IN CONSULTATION WITH THE COMMISSIONER OF MOTOR VEHICLES, IS HEREBY AUTHORIZED AND DIRECTED TO ESTABLISH WITHIN THE DEPARTMENT, A SAVE OUR SIGHT PROGRAM. SUCH PROGRAM SHALL:
- 1. PROVIDE SUPPORT TO NONPROFIT ORGANIZATIONS THAT OFFER VISION SCREENING AND EDUCATION SERVICES;
- 9 2. IMPLEMENT A VOLUNTARY CHILDREN'S VISION SCREENING TRAINING AND 10 CERTIFICATION PROGRAM FOR VOLUNTEERS, CHILD DAY-CARE PROVIDERS, NURSES, TEACHERS, HEALTH CARE PROFESSIONALS PRACTICING IN PRIMARY CARE SETTINGS 11 12 AND FOR OTHER PERSONS SERVING CHILDREN;
- DEVELOP AND IMPLEMENT A REGISTRY AND TARGETED VOLUNTARY CASE MANAGEMENT SYSTEM TO DETERMINE WHETHER CHILDREN WITH AMBLYOPIA ARE 14 RECEIVING PROFESSIONAL EYE CARE AND TO PROVIDE PARENTS AND LEGAL GUARDI-ANS OF CHILDREN WITH AMBLYOPIA WITH INFORMATION AND SUPPORT REGARDING SUCH CHILDREN'S VISION;
- 4. ESTABLISH A MATCHING GRANT PROGRAM FOR THE PURCHASE 18 AND DISTRIB-19 UTION OF PROTECTIVE EYEWEAR TO CHILDREN;
- 20 5. PROVIDE VISION HEALTH AND SAFETY PROGRAMS AND MATERIALS TO CLASS-21 ROOMS; AND
- 22 6. FOR THE PURPOSES OF SECTION FOUR HUNDRED ONE-C OF THE VEHICLE 23 TRAFFIC LAW, TO DEVELOP MATERIALS ON THE IMPORTANCE OF EYE CARE AND

SAFETY AND TO DELIVER SUCH MATERIALS TO THE COMMISSIONER OF MOTOR VEHI-CLES FOR DISTRIBUTION PURSUANT TO SECTION FOUR HUNDRED ONE-C OF THE 3 VEHICLE AND TRAFFIC LAW.

- The vehicle and traffic law is amended by adding a new section 401-c to read as follows:
- 6 S 401-C. SAVE OUR SIGHT PROGRAM; VOLUNTARY CONTRIBUTION. IN ADDITION 7 TO THE FEES COLLECTED PURSUANT TO THIS ARTICLE, EVERY APPLICATION FOR REGISTRATION OR RENEWAL REGISTRATION OF A MOTOR VEHICLE AND EVERY APPLI-CATION FOR AN OPERATOR'S LICENSE OR FOR RENEWAL THEREOF SHALL PROVIDE AN 9 10 OPTION TO THE OWNER OF THE VEHICLE BEING REGISTERED OR APPLICANT TO MAKE A ONE-DOLLAR VOLUNTARY CONTRIBUTION TO THE SAVE OUR SIGHT 11 LISHED PURSUANT TO SECTION EIGHTY-ONE OF THE STATE FINANCE LAW. THE COMMISSIONER SHALL COLLECT SUCH ADDITIONAL ONE DOLLAR FROM ANY PERSON 12 13 WHO OPTS TO CONTRIBUTE TO SUCH FUND. THE COMMISSIONER SHALL ALSO MAKE 14 AVAILABLE TO EVERY PERSON APPLYING FOR REGISTRATION OR RENEWAL REGISTRA-15 16 TION OF A MOTOR VEHICLE AND EVERY APPLICATION FOR AN OPERATOR'S LICENSE OR FOR RENEWAL THEREOF MATERIALS ON THE IMPORTANCE OF EYE CARE AND SAFE-17 PROVIDED BY THE COMMISSIONER OF HEALTH PURSUANT TO SECTION 18 19 TWENTY-THREE OF THE PUBLIC HEALTH LAW. THE COMMISSIONER SHALL FORWARD ALL MONEYS RECEIVED PURSUANT TO THE PROVISIONS OF THIS SECTION TO THE 20 COMPTROLLER FOR DEPOSIT INTO THE SAVE OUR SIGHT FUND ESTABLISHED PURSU-21 ANT TO SECTION EIGHTY-ONE OF THE STATE FINANCE LAW.
- 3. The state finance law is amended by adding a new section 81 to 23 24 read as follows:
- S 81. SAVE OUR SIGHT FUND. 1. THERE IS HEREBY ESTABLISHED 26 THE STATE COMPTROLLER, A FUND TO BE KNOWN AS THE SAVE OUR SIGHT FUND. 27
- 28 2. SUCH FUND SHALL CONSIST OF ALL MONEYS APPROPRIATED FOR THE PURPOSE 29 OF SUCH FUND, ALL MONEYS TRANSFERRED TO SUCH FUND PURSUANT TO LAW AND ALL MONEYS REQUIRED TO BE PAID TO THE CREDIT OF SUCH FUND 30 PURSUANT SECTION FOUR HUNDRED ONE-C OF THE VEHICLE AND TRAFFIC LAW. 31
 - MONEYS OF THE FUND SHALL BE AVAILABLE FOR APPROPRIATION AND ALLO-CATION ONLY TO THE COMMISSIONER OF HEALTH FOR THE PURPOSES OF CARRYING THE PROVISIONS OF SECTION TWENTY-THREE OF THE PUBLIC HEALTH LAW AND SECTION FOUR HUNDRED ONE-C OF THE VEHICLE AND TRAFFIC LAW.
- 4. MONEYS OF THE FUND, WHEN AVAILABLE, SHALL BE PAID OUT ON THE AUDIT 36 AND WARRANT OF THE COMPTROLLER ON VOUCHERS CERTIFIED OR APPROVED BY THE 37 COMMISSIONER OF HEALTH OR BY AN OFFICER OR EMPLOYEE OF THE DEPARTMENT OF 38 39 HEALTH DESIGNATED BY SUCH COMMISSIONER.
- 40 S 4. This act shall take effect immediately.
