AN ACT to amend the alcoholic beverage control law, in relation to a license to sell liquor at retail for consumption on certain premises

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivision 7 of section 64 of the alcoholic beverage 2 control law is amended by adding a new paragraph (e-7) to read as 3 follows:
- (E-7) NOTWITHSTANDING THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDIVI-5 SION, THE AUTHORITY MAY ISSUE A RETAIL LICENSE FOR ON-PREMISES CONSUMP-TION FOR A PREMISES WHICH SHALL BE LOCATED WITHIN TWO HUNDRED FEET OF A 7 BUILDING OCCUPIED EXCLUSIVELY AS A CHURCH, SYNAGOGUE OR OTHER PLACE OF WORSHIP, PROVIDED SUCH PREMISES CONSTITUTES A PREMISES FOR THE SALE OF 8 FOOD OR BEVERAGES AT RETAIL FOR CONSUMPTION ON THE PREMISES 9 LOCATED 10 WHOLLY WITHIN THE BOUNDARIES OF THE COUNTY OF KINGS, BOUNDED AND DESCRIBED AS FOLLOWS: ALL THAT TRACT OR PARCEL OF LAND, SITUATE 11 12 CITY OF BEACON, COUNTY OF DUTCHESS, AND THE STATE OF NEW YORK, BOUNDED
- 13 AND DESCRIBED AS FOLLOWS:
- 14 BEGINNING AT A POINT IN THE SOUTHERLY LINE OF MAIN STREET, SAID POINT
- 15 BEING NORTH 53 DEGREES 01 MINUTES 40 SECONDS WEST A DISTANCE OF 250.21
- 16 FEET FROM THE INTERSECTION OF THE SAID SOUTHERLY LINE OF MAIN STREE
- 17 WITH THE WESTERLY LINE OF TELLER AVENUE, SAID POINT OF BEGINNING ALSO
- 18 BEING THE SOUTHEASTERLY CORNER OF THE PORTION OF THE PARCEL DESCRIBED IN
- 19 L. 2011 P. 4608 WHICH IS NOW OR FORMERLY OCCUPIED BY THE TOWN CRIER
- 20 CAFE.
- 21 THENCE THROUGH SAID PARCEL SOUTH 36 DEGREES 58 MINUTES 20 SECONDS WEST A
- 22 DISTANCE OF 100.00 FEET TO A POINT, SAID POINT BEING THE SOUTHWESTERLY
- 23 CORNER OF THE PORTION OF THE SAID PARCEL WHICH IS NOW OR FORMERLY OCCU-
- 24 PIED BY THE TOWN CRIER CAFE;
