AN ACT to amend the administrative code of the city of New York, in relation to the reporting of criminal activity on subways

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 14-150 of the administrative code of the city of Section 1. New York is amended by adding a new subdivision d to read as follows:

THE NEW YORK CITY POLICE DEPARTMENT SHALL SUBMIT TO THE CITY COUN-CIL ANNUALLY A REPORT DETAILING THE TOTAL NUMBER OF CRIMINAL COMPLAINTS AND ARRESTS, CATEGORIZED BY CLASS OF CRIME, FOR VIOLENT FELONY OFFENSES DEFINED IN SECTION 70.02 OF THE PENAL LAW, ASSAULT AND RELATED OFFENSES AS DEFINED IN ARTICLE ONE HUNDRED TWENTY OF THE PENAL LAW, OFFENSES AS DEFINED IN ARTICLE ONE HUNDRED THIRTY OF THE PENAL LAW, DISORDERLY CONDUCT AS DEFINED SECTION 240.20 OF IN $_{
