AN ACT to amend the executive law, in relation to fees for drug testing and electronic monitoring

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 2, 3, 4, and 5 of section 257-c of the execu-2 tive law are renumbered subdivisions 4, 5, 6, and 7 and two new subdivi-3 sions 2 and 3 are added to read as follows:

4 2. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, EVERY COUNTY AND THE 5 CITY OF NEW YORK, MAY ADOPT A LOCAL LAW REQUIRING INDIVIDUALS CURRENTLY 6 SERVING OR WHO SHALL BE SENTENCED TO A PERIOD OF PROBATION UPON CONVICTION OF ANY CRIME AND WHO ARE REQUIRED TO SUBMIT TO DRUG 7 TESTING, 8 PAY THE LOCAL PROBATION DEPARTMENT WITH THE RESPONSIBILITY OF SUPER-TO 9 VISING THE PROBATIONER AN ADMINISTRATIVE FEE DETERMINED BY THELOCAL PROBATION DEPARTMENT. THE DEPARTMENT SHALL WAIVE ALL OR PART OF SUCH FEE 10 WHERE, BECAUSE OF THE INDIGENCE OF THE OFFENDER, THE PAYMENT OF SAID 11 12 SURCHARGE WOULD WORK AN UNREASONABLE HARDSHIP ON THE PERSON CONVICTED, 13 IMMEDIATE FAMILY, OR ANY OTHER PERSON WHO IS DEPENDENT ON HIS OR HER 14 SUCH PERSON FOR FINANCIAL SUPPORT.

15 3. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, EVERY COUNTY AND THE CITY OF NEW YORK, MAY ADOPT A LOCAL LAW REQUIRING INDIVIDUALS CURRENTLY 16 17 SERVING OR WHO SHALL BE SENTENCED TO A PERIOD OF PROBATION UPON ANY CRIME AND WHO ARE REQUIRED TO SUBMIT TO ELECTRONIC 18 CONVICTION OF MONITORING, TO PAY THE LOCAL PROBATION DEPARTMENT WITH THE RESPONSIBIL-19 ITY OF SUPERVISING THE PROBATIONER AN ADMINISTRATIVE FEE DETERMINED BY 20 THE LOCAL PROBATION DEPARTMENT. THE DEPARTMENT SHALL WAIVE ALL OR 21 PART OF SUCH FEE WHERE, BECAUSE OF THE INDIGENCE OF THE OFFENDER, THE PAYMENT 22 23 SAID SURCHARGE WOULD WORK AN UNREASONABLE HARDSHIP ON THE PERSON OF 24 CONVICTED, HIS OR HER IMMEDIATE FAMILY, OR ANY OTHER PERSON WHO IS 25 DEPENDENT ON SUCH PERSON FOR FINANCIAL SUPPORT.
