AN ACT to amend the alcoholic beverage control law, in relation to
providing alcoholic beverages on credit to an individual person

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 6 and 7 of section 100 of the alcoholic bever-
2 age control law, subdivision 6 as added by chapter 526 of the laws of
3 1939 and subdivision 7 as added by chapter 256 of the laws of 1978, are
4 amended to read as follows:
5 6. NOTWITHSTANDING SUBDIVISION FIVE OF THIS SECTION, A RETAIL LICENSEE
6 FOR OFF-PREMISES CONSUMPTION MAY SELL, DELIVER, GIVE AWAY, HOLD OR
7 STORE, OR CAUSE, PERMIT OR PROCURE TO BE SOLD, DELIVERED, GIVEN AWAY,
8 HELD OR STORED, ANY ALCOHOLIC BEVERAGE ON CREDIT TO ANY INDIVIDUAL
9 PERSON, PROVIDED THAT THE ORDER ON CREDIT IS AT LEAST TWO HUNDRED
10 DOLLARS. THE PROVISION OF THIS SUBDIVISION SHALL STILL APPLY IF THE
11 RETAIL LICENSEE RETAINS THE ALCOHOLIC BEVERAGE FOR THE INDIVIDUAL
12 PERSON.
13 7. No licensee shall sell or purchase any receipts, certificates,
14 contracts or other documents issued for the storage of alcoholic bever-
15 ages except as provided by the rules of the liquor authority. The liquor
16 authority shall prescribe such rules for the purchase and sale of such
17 receipts, certificates, contracts or other documents issued for the
18 storage of alcoholic beverages which, in its opinion, will best accom-
19 plish
20 (1) Elimination of fraudulent and deceptive transactions;
21 (2) Protection of purchasers against defaults by sellers;
22 (3) The delivery of the alcoholic beverages represented by such
23 receipts or documents, and

1 (4) The payment of all taxes due thereon to the state.
2 [7.] 8. Within ten days after filing a new application to sell liquor
3 at retail under section sixty-three, sixty-four, sixty-four-a or sixty-
4 four-b of this chapter, a notice thereof, in the form prescribed by the
5 authority, shall be posted by the applicant in a conspicuous place at
6 the entrance to the proposed premises. The applicant shall make reason-
7 able efforts to insure such notice shall remain posted throughout the
8 pendency of the application. The provisions hereof shall apply only
9 where no retail liquor license has previously been granted for the
10 proposed premise and shall, specifically, not be applicable to a
11 proposed sale of an existing business engaged in the retail sale of
12 liquor. The authority may adopt such rules it may deem necessary to
13 carry out the purpose of this subdivision.
14 S 2. This act shall take effect immediately.
