AN ACT to amend the environmental conservation law, in relation to creating a public awareness campaign for the purpose of educating the public about the three non-native species present in this state with the highest invasiveness assessment ratings, including Japanese knotweed

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 9-1709 of the environmental conservation law is amended by adding a new subdivision 3 to read as follows:

- 3.(A) THE COMMISSIONER, IN COOPERATION WITH THE DEPARTMENT OF AGRICULTURE AND MARKETS, AND THE INVASIVE SPECIES COUNCIL CREATED PURSUANT TO SECTION 9-1705 OF THIS ARTICLE, SHALL DEVELOP A PUBLIC AWARENESS CAMPAIGN FOR THE PURPOSE OF EDUCATING THE PUBLIC ABOUT THE THREE NON-NATIVE PLANT SPECIES PRESENT IN THIS STATE WITH THE HIGHEST INVASIVENESS ASSESSMENT RATINGS, INCLUDING BUT NOT LIMITED TO JAPANESE KNOTWEED (REYNOUTRIA JAPONICA, FALLOPIA JAPONICA, AND POLYGONUM CUSPIDATUM).
- 10 (B) SUCH CAMPAIGN SHALL INCLUDE, BUT NOT BE LIMITED TO, DISTRIBUTING 11 INFORMATIONAL MATERIALS RELATING TO IDENTIFYING SUCH INVASIVE SPECIES 12 AND THE BEST MANAGEMENT PRACTICES FOR CONTAINMENT, REMOVAL AND DISPOSAL.
- 13 AS PART OF THE PROCESS TO DEVELOP THE INFORMATIONAL MATERIALS, THE 14 DEPARTMENT, THE DEPARTMENT OF AGRICULTURE AND MARKETS AND THE INVASIVE
- 14 DEPARTMENT, THE DEPARTMENT OF AGRICULTURE AND MARKETS AND THE INVASIVE 15 SPECIES COUNCIL SHALL CONDUCT OUTREACH TO STAKEHOLDERS, INCLUDING BUT
- 16 NOT LIMITED TO SOIL AND WATER CONSERVATION DISTRICTS. ONCE CREATED, THE
- 17 INFORMATIONAL MATERIALS SHALL BE MADE WIDELY AVAILABLE TO THE PUBLIC
- 18 AND, AT A MINIMUM SHALL BE PLACED ON THE WEBSITE OF THE DEPARTMENT.

- 1 (C)(I) THE DEPARTMENT SHALL ESTABLISH, NO LATER THAN ONE YEAR AFTER
  2 THE EFFECTIVE DATE OF THIS SUBDIVISION, AT LEAST TWO FIVE-YEAR PILOT
  3 PROGRAMS TO DETERMINE THE MOST COST-EFFECTIVE METHOD OF REMOVING THE
  4 NON-NATIVE PLANT SPECIES IDENTIFIED IN PARAGRAPH (A) OF THIS SUBDIVI5 SION. AT LEAST ONE OF THE PILOT PROGRAMS SHALL INCLUDE JAPANESE KNOT6 WEED. THE PROGRAMS SHALL BE ESTABLISHED AT LOCATIONS TO BE DETERMINED
  7 BY THE DEPARTMENT.
- 8 (II) WHILE CONDUCTING SUCH PILOT PROGRAMS THE COMMISSIONER SHALL 9 RELEASE ANNUAL REPORTS TO THE LEGISLATURE INCLUDING METHODS USED, THE 10 COST OF THE ERADICATION PROGRAMS AND ANY ADVERSE EFFECTS AND BENEFITS TO 11 LOCAL FLORA AND FAUNA.
- 12 S 2. This act shall take effect on the sixtieth day after it shall 13 have become a law.
