Introduced by M. of A. BRINDISI, CLARK -- read once and referred to the Committee on Social Services -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee

AN ACT to amend the social services law, in relation to additional state payments to aged, blind and disabled and personal allowance accounts for individuals receiving enhanced residential care

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     Section 1. Paragraph (c) of subdivision 1 of section 131-o of the  
2     social services law, as amended by section 1 of part I of chapter 56 of  
3     the laws of 2015, is amended to read as follows:  
4     (c) (1) in the case of each individual receiving enhanced residential  
5     care, an amount equal to at least \$193.00 for each month beginning on or  
6     after January first, two thousand fifteen.  
7     (2) IN THE CASE OF EACH INDIVIDUAL RECEIVING ENHANCED RESIDENTIAL  
8     CARE, AN AMOUNT EQUAL TO AT LEAST \$217.00 FOR EACH MONTH BEGINNING ON OR  
9     AFTER APRIL FIRST, TWO THOUSAND SIXTEEN.  
10    S 2. Paragraphs (e) and (f) of subdivision 2 of section 209 of the  
11    social services law, as amended by section 2 of part I of chapter 56 of  
12    the laws of 2015, are amended to read as follows:  
13    (e) (i) (1) On and after January first, two thousand fifteen, for an  
14    eligible individual receiving enhanced residential care, \$1427.00; and  
15    [(ii)] (2) for an eligible couple receiving enhanced residential care,  
16    two times the amount set forth in [subparagraph (i)] CLAUSE ONE of this  
17    [paragraph] SUBPARAGRAPH.  
18    (II) (1) ON AND AFTER APRIL FIRST, TWO THOUSAND SIXTEEN, FOR AN ELIGI-  
19    BLE INDIVIDUAL RECEIVING ENHANCED RESIDENTIAL CARE, \$1601.00; AND (2)  
20    FOR AN ELIGIBLE COUPLE RECEIVING ENHANCED RESIDENTIAL CARE, TWO TIMES  
21    THE AMOUNT SET FORTH IN CLAUSE ONE OF THIS SUBPARAGRAPH.  
22    (f) (I) The amounts set forth in paragraphs (a) through (e) of this  
23    subdivision shall be increased to reflect any increases in federal

4 (II) IN ADDITION TO THE AMOUNTS PROVIDED IN SUBPARAGRAPH (I) OF THIS  
5 PARAGRAPH, ON AND AFTER APRIL FIRST, TWO THOUSAND SIXTEEN, THE ADDI-  
6 TIONAL STATE PAYMENT PORTION OF THE AMOUNTS SET FORTH IN PARAGRAPH (E)  
7 OF THIS SUBDIVISION SHALL BE ANNUALLY INCREASED BY THE SAME PERCENTAGE  
8 OF ANY FEDERAL SUPPLEMENTAL SECURITY INCOME COST OF LIVING ADJUSTMENT  
9 WHICH BECOMES EFFECTIVE ON OR AFTER JANUARY FIRST, BUT PRIOR TO JUNE  
10 THIRTIETH, OF EACH CALENDAR YEAR, ROUNDED TO THE NEAREST WHOLE DOLLAR.

11 S 3. This act shall take effect on the same date and in the same  
12 manner as part I of chapter 56 of the laws of 2015, takes effect.
