AN ACT to amend the election law, in relation to enacting the "Modernized Voter Registration Act of New York"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. This act shall be known and may be cited as the "Modernized Voter Registration Act of New York".

3 S 2. The election law is amended by adding four new sections 5-200, 4 5-201, 5-205 and 5-207 to read as follows:
