AN ACT to amend the penal law, in relation to assault on a member of an
auxiliary police program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 3 and 10 of section 120.05 of the penal law,
2 subdivision 3 as amended by chapter 196 of the laws of 2014, subdivision
3 10 as added by chapter 181 of the laws of 2000, are amended to read as
4 follows:

5 3. With intent to prevent a peace officer, a police officer, A MEMBER
6 OF AN AUXILIARY POLICE PROGRAM ORGANIZED AND MAINTAINED BY A STATE OR
7 LOCAL POLICE DEPARTMENT OR SHERIFF'S DEPARTMENT WHILE PERFORMING HIS OR
8 HER DUTIES AS SUCH AUXILIARY POLICE OFFICER, prosecutor as defined in
9 subdivision thirty-one of section 1.20 of the criminal procedure law,
10 registered nurse, licensed practical nurse, sanitation enforcement
11 agent, New York city sanitation worker, a firefighter, including a fire-
12 fighter acting as a paramedic or emergency medical technician adminis-
13 tering first aid in the course of performance of duty as such firefight-
14 er, an emergency medical service paramedic or emergency medical service
15 technician, or medical or related personnel in a hospital emergency
16 department, a city marshal, a school crossing guard appointed pursuant
17 to section two hundred eight-a of the general municipal law, a traffic
18 enforcement officer or traffic enforcement agent, from performing a
19 lawful duty, by means including releasing or failing to control an
20 animal under circumstances evincing the actor's intent that the animal
21 obstruct the lawful activity of such peace officer, police officer,
22 ON-DUTY AUXILIARY POLICE OFFICER, prosecutor as defined in subdivision
23 thirty-one of section 1.20 of the criminal procedure law, registered
24 nurse, licensed practical nurse, sanitation enforcement agent, New York
25 city sanitation worker, firefighter, paramedic, technician, city

1 marshal, school crossing guard appointed pursuant to section two hundred

3 traffic enforcement agent, he or she causes physical injury to such
4 peace officer, police officer, ON-DUTY AUXILIARY POLICE OFFICER, prose-
5 cutor as defined in subdivision thirty-one of section 1.20 of the crimi-
6 nal procedure law, registered nurse, licensed practical nurse, sanita-
7 tion enforcement agent, New York city sanitation worker, firefighter,
8 paramedic, technician or medical or related personnel in a hospital
9 emergency department, city marshal, school crossing guard, traffic
10 enforcement officer or traffic enforcement agent; or

11 10. Acting at a place the person knows, or reasonably should know, is
12 on school grounds and with intent to cause physical injury, he or she:

13 (a) causes such injury to an employee of a school or public school
14 district OR TO A SCHOOL SAFETY AGENT EMPLOYED BY A CITY WITH A POPU-
15 LATION OF ONE MILLION OR MORE; or

16 (b) not being a student of such school or public school district,
17 causes physical injury to another, and such other person is a student of
18 such school who is attending or present for educational purposes. For
19 purposes of this subdivision the term "school grounds" shall have the
20 meaning set forth in subdivision fourteen of section 220.00 of this
21 chapter.

22 S 2. This act shall take effect on the sixtieth day after it shall
