AN ACT to amend the vehicle and traffic law and the administrative code of the city of New York, in relation to requiring background checks for for-hire vehicle licenses

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The vehicle and traffic law is amended by adding a new article 17-D to read as follows:

S 499-M. BACKGROUND CHECK FOR FOR-HIRE VEHICLE LICENSES. PRIOR TO THE ISSUANCE OF A TAXICAB, LIMOUSINE, COMMUTER VAN, PARATRANSIT OR FOR-HIRE VEHICLE LICENSE, THE APPLICANT FOR SUCH LICENSE SHALL BE FINGERPRINTED THE LICENSING AUTHORITY AUTHORIZED TO ISSUE SUCH LICENSE FOR THE PURPOSE OF SECURING CRIMINAL HISTORY RECORDS FROM BOTH THE STATE DIVI-SION OF CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU OF INVESTI-THE APPLICANT SHALL PAY ANY PROCESSING FEEREOUIRED BY CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU OF STATE DIVISION OF INVESTIGATION. FINGERPRINTS SHALL BE TAKEN OF THE INDIVIDUAL OWNER APPLICANT IS A SOLE PROPRIETORSHIP; THE GENERAL PARTNERS IF THE APPLICANT IS A PARTNERSHIP; THE OFFICERS, PRINCIPALS, AND STOCKHOLDERS OWNING MORE THAN TEN PERCENT OF THE OUTSTANDING STOCK OF THE CORPORATION IF THE APPLICANT IS A CORPORATION.

- 19 S 2. Subdivision l of section 19-504 of the administrative code of the 20 city of New York, as added by local law number 115 of the city of New 21 York for the year 1993, is amended and a new subdivision r is added to 22 read as follows:
- 23 l. Prior to the issuance of a commuter van license, the applicant 24 shall be fingerprinted for the purpose of securing criminal history

records from BOTH the state division of criminal justice services AND THE FEDERAL BUREAU OF INVESTIGATION. The applicant shall pay any proc-3 essing fee required by the state division of criminal justice services AND THE FEDERAL BUREAU OF INVESTIGATION. Fingerprints shall be taken of individual owner if the applicant is a sole proprietorship; the 5 general partners if the applicant is a partnership; the officers, prin-6 7 cipals, and stockholders owning more than ten percent of the outstanding 8 stock of the corporation if the applicant is a corporation.

R. PRIOR TO THE ISSUANCE OF A TAXICAB, LIMOUSINE, PARATRANSIT OR FOR-10 HIRE VEHICLE LICENSE, THE APPLICANT SHALL BE FINGERPRINTED FOR THE SECURING CRIMINAL HISTORY RECORDS FROM BOTH THE STATE DIVI-SION OF CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU OF 12 INVESTI-GATION. THE APPLICANT SHALL PAY ANY PROCESSING FEE REQUIRED BY THE STATE 13 14 DIVISION OF CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU OF INVESTI-15 FINGERPRINTS SHALL BE TAKEN OF THE INDIVIDUAL OWNER IF THE APPLICANT IS A SOLE PROPRIETORSHIP; THE GENERAL PARTNERS IF THE APPLI-CANT IS A PARTNERSHIP; THE OFFICERS, PRINCIPALS, AND STOCKHOLDERS OWNING 17 MORE THAN TEN PERCENT OF THE OUTSTANDING STOCK OF THE CORPORATION IF THE 18 19 APPLICANT IS A CORPORATION.

This act shall take effect on the sixtieth day after it shall 20 21 have become a law.
