AN ACT to amend the general business law and the civil practice law and rules, in relation to process servers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 89-t of the general business law, as added by chap-2 ter 397 of the laws of 1973 and as redesignated by chapter 336 of the 3 laws of 1992, is amended to read as follows:

4 89-t. Definitions. 1. For this article, a "process server" is a S 5 person other than an attorney or a party to an action acting on his own behalf who: (a) derives income from the service of papers in an action; 6 7 has effected service of process in five or more actions or (b) or 8 proceedings in the twelve month period immediately preceding the service 9 in question. A person who serves interlocutory papers upon an attorney or who serves papers on behalf of a federal, state or local governmental 10 agency in the course of his employment by such agency shall not be 11 deemed a process server within the meaning of this article by virtue of 12 such service. FOR THE PURPOSES OF THIS CHAPTER THE SERVICE OF FIVE OR 13 14 MORE PROCESS IN ANY ONE YEAR SHALL BE DEEMED TO CONSTITUTE DOING BUSI-15 NESS AS A PROCESS SERVER.

16 2. "DEPARTMENT" SHALL MEAN DEPARTMENT OF STATE.

17 3. "SECRETARY" SHALL MEAN SECRETARY OF STATE.

18 S 2. Article 8 of the general business law is amended by adding a new 19 section 89-x to read as follows:

20 S 89-X. PROCESS SERVER, LICENSING, PENALTIES. 1. ISSUANCE, RENEWAL, 21 SUSPENSION AND REVOCATION OF A LICENSE. ON OR AFTER OCTOBER FIRST, TWO 22 THOUSAND FIFTEEN, NO PERSON SHALL ACT AS A PROCESS SERVER WITHOUT FIRST 23 HAVING OBTAINED A LICENSE IN ACCORDANCE WITH THE PROVISIONS OF THIS 24 ARTICLE, AND WITHOUT FIRST BEING IN COMPLIANCE WITH ALL OTHER APPLICABLE 25 LAWS, RULES AND REGULATIONS.

26 2. (A) ALL LICENSES ISSUED PURSUANT TO THIS ARTICLE SHALL BE VALID FOR 27 TWO YEARS UNLESS SOONER SUSPENDED OR REVOKED. THE SECRETARY SHALL ESTAB-28 LISH BY REGULATION THE EXPIRATION DATE OF SUCH LICENSES.

IN DETERMINING WHETHER TO ISSUE OR RENEW A LICENSE, THE SECRETARY 35 SHALL CONSIDER THE CHARACTER, COMPETENCY AND INTEGRITY OF THE APPLICANT. THE SECRETARY MAY REFUSE TO ISSUE OR RENEW A LICENSE TO ANY PERSON, FIRM 36 37 OR CORPORATION WHOM HE OR SHE FINDS HAS: BEEN CONVICTED OF ANY CRIME 38 DEFINED IN ARTICLE ONE HUNDRED FIFTY-FIVE OF THE PENAL LAW OR ARTICLE 39 TWENTY-TWO-A OF THIS CHAPTER OR FAILED TO PAY ANY FINAL CIVIL JUDGMENT 40 RELATING TO WORK AS A PROCESS SERVER, IF SUCH REFUSAL, IN THE JUDGMENT OF THE SECRETARY, BEST PROMOTES THE INTERESTS OF THE PEOPLE OF THIS 41 42 STATE. 43 5. NOTICE IN WRITING IN THE MANNER AND FORM PRESCRIBED BY THE DEPART-44 MENT SHALL BE GIVEN TO THE DEPARTMENT AT ITS OFFICES IN ALBANY WITHIN 45 TEN DAYS OF CHANGES OF NAME OR ADDRESS BY LICENSED PROCESS SERVER. THE FEE FOR FILING EACH CHANGE OF NAME OR ADDRESS NOTICE SHALL BE TEN 46 47 DOLLARS. 48 6. THE FEES ESTABLISHED BY THIS SECTION SHALL NOT BE REFUNDABLE. 49 7. EACH PROCESS SERVER ENGAGED IN SERVING PROCESS SHALL COMMUNICATE 50 HIS OR HER LICENSE NUMBER UPON THE REQUEST OF ANY INTERESTED PARTY. ANY 51 ADVERTISEMENT, LETTERHEAD, RECEIPT OR OTHER PRINTED MATTER OF A LICENSEE MUST CONTAIN THE LICENSE NUMBER ASSIGNED TO THE LICENSEE BY THE DEPART-52 MENT. SUCH LICENSE NUMBER SHALL BE CLEARLY AND CONSPICUOUSLY DISPLAYED. 53 54 8. (B) KNOWINGLY GIVE FALSE EVIDENCE OF A MATERIAL NATURE TO THE DEPART-1 2 MENT FOR THE PURPOSE OF PROCURING A LICENSE; (C) FALSELY REPRESENT THEMSELVES TO BE A LICENSED PROCESS SERVER; 3 4 (D) USE OR ATTEMPT TO USE A LICENSE WHICH HAS EXPIRED; 5 OFFER TO PERFORM OR PERFORM ANY SERVICE OF PROCESS WITHOUT HAVING (E) 6 A CURRENT LICENSE AS IS REQUIRED UNDER THIS ARTICLE; OR 7 (F) REPRESENT IN ANY MANNER THAT HIS, HER OR ITS LICENSE CONSTITUTES 8 AN ENDORSEMENT OF THE QUALITY OF WORKMANSHIP OR COMPETENCY OF THE PROC-9 ESS SERVER. 10 9. LICENSES ISSUED TO PROCESS SERVERS SHALL NOT BE TRANSFERABLE OR 11 ASSIGNABLE. 12 10. THE SECRETARY SHALL ISSUE EACH PROCESS SERVER A UNIQUE LICENSE 13 NUMBER. 14 11. THE SECRETARY SHALL MAINTAIN AND PUBLISH A REGISTRY OF ALL 15 LICENSED PROCESS SERVERS WHICH SHALL LIST AND IDENTIFY ALL LICENSED PROCESS SERVERS DOING BUSINESS IN THIS STATE. THE SECRETARY SHALL MAKE 16 17 REGISTRY AVAILABLE ON ITS WEBSITE. (A) THE SECRETARY SHALL ADOPT THE SUCH RULES AND REGULATIONS AS HE OR SHE MAY DETERMINE ARE NECESSARY FOR 18 19 THE ADMINISTRATION AND ENFORCEMENT OF THIS ARTICLE, AND SHALL PROVIDE WRITTEN NOTIFICATION OF THE PROVISIONS OF THIS ARTICLE TO ALL PROCESS 20 21 SERVERS LICENSED PURSUANT TO THIS ARTICLE; 22 (B) IN ADDITION TO ANY OTHER POWERS OF THE SECRETARY, NOT IN LIMITA-23 TION THEREOF, HE OR SHE SHALL HAVE THE POWER TO ENFORCE THE PROVISIONS THIS ARTICLE, TO INVESTIGATE ANY VIOLATION THEREOF, TO INVESTIGATE 24 OF 25 THE BUSINESS, BUSINESS PRACTICES AND BUSINESS METHODS OF ANY PROCESS 26 SERVER, AND TO CONDUCT ROUTINE EXAMINATIONS OF THE FINANCIAL SOLVENCY OF ANY PROCESS SERVER, IF IN THE OPINION OF THE SECRETARY, SUCH INVESTI-27 GATION OR EXAMINATION IS WARRANTED. EACH PROCESS SERVER SHALL BE 28 OBLIGED, ON REQUEST OF THE SECRETARY OF STATE, TO SUPPLY SUCH INFORMA-29 TION, BOOKS, PAPERS OR RECORDS AS MAY BE REQUIRED CONCERNING HIS, HER OR 30 ITS BUSINESS, BUSINESS PRACTICES OR BUSINESS METHODS, OR PROPOSED BUSI-31 NESS PRACTICES OR METHODS. FAILURE TO COMPLY WITH A LAWFUL REQUEST OF 32 33 THE SECRETARY SHALL BE A GROUND FOR DENYING AN APPLICATION FOR A 34 LICENSE, OR FOR REVOKING, SUSPENDING, OR FAILING TO RENEW A LICENSE ISSUED UNDER THIS ARTICLE; 35 (C) THE DEPARTMENT SHALL HAVE THE POWER TO REVOKE OR SUSPEND ANY 36 37 LICENSE, OR IN LIEU THEREOF TO IMPOSE A FINE NOT LESS THAN ONE HUNDRED 38 DOLLARS NOR MORE THAN TWO THOUSAND DOLLARS PER VIOLATION OR INSTANCE, 39 PAYABLE TO THE DEPARTMENT, OR REPRIMAND ANY LICENSEE OR DENY AN APPLICA-40 TION FOR A LICENSE OR RENEWAL THEREOF UPON PROOF: (I) THAT THE APPLICANT OR LICENSEE HAS VIOLATED ANY OF THE PROVISIONS 41 OF THIS ARTICLE OR THE RULES AND REGULATIONS PROMULGATED PURSUANT 42 TO 43 THIS ARTICLE; 44 (II) THAT THE APPLICANT OR LICENSEE HAS PRACTICED FRAUD, DECEIT OR 45 MISREPRESENTATION; 46 (III) THAT THE APPLICANT OR LICENSEE HAS MADE A MATERIAL MISSTATEMENT 47 IN THE APPLICATION FOR OR RENEWAL OF HIS OR HER LICENSE; OR 48 (IV) THAT THE APPLICANT OR LICENSEE HAS DEMONSTRATED INCOMPETENCE OR 49 UNTRUSTWORTHINESS IN HIS OR HER ACTIONS. 50 12. THE DEPARTMENT SHALL BEFORE DENYING AN APPLICATION FOR A LICENSE 51 BEFORE REVOKING OR SUSPENDING ANY LICENSE, OR IMPOSING ANY FINE OR OR REPRIMAND, AND AT LEAST FIFTEEN DAYS PRIOR TO THE DATE SET FOR THE HEAR-52 ING, AND UPON DUE NOTICE TO THE COMPLAINANT OR OBJECTOR, NOTIFY IN WRIT-53 54 ING THE APPLICANT, OR THE HOLDER OF SUCH LICENSE, OF ANY CHARGE MADE AND 55 SHALL AFFORD SUCH APPLICANT OR LICENSEE AN OPPORTUNITY TO BE HEARD IN 56 PERSON OR BY COUNSEL IN REFERENCE THERETO. SUCH WRITTEN NOTICE MAY BE 1 SERVED PERSONALLY TO THE APPLICANT OR LICENSEE, OR BY CERTIFIED MAIL TO 2 THE LAST KNOWN BUSINESS ADDRESS OF SUCH APPLICANT OR LICENSEE.

3 13. THE HEARING ON SUCH CHARGES SHALL BE AT SUCH TIME AND PLACE AS THE 4 DEPARTMENT SHALL PRESCRIBE AND SHALL BE CONDUCTED BY SUCH OFFICER OR 5 PERSON IN THE DEPARTMENT AS THE SECRETARY MAY DESIGNATE, WHO SHALL HAVE 6 POWER TO SUBPOENA AND BRING BEFORE THE OFFICER, OR PERSON SO DESIG-THE 7 NATED, ANY PERSON IN THIS STATE AND ADMINISTER AN OATH TO AND TAKE 8 TESTIMONY OF ANY PERSON OR CAUSE HIS OR HER DEPOSITION TO BE TAKEN. A 9 SUBPOENA ISSUED UNDER THIS SECTION SHALL BE REGULATED BY THE CIVIL PRAC-10 TICE LAW AND RULES. SUCH OFFICER OR PERSON IN THE DEPARTMENT DESIGNATED TO TAKE SUCH TESTIMONY SHALL NOT BE BOUND BY COMMON LAW OR STATUTORY 11 RULES OF EVIDENCE OR BY TECHNICAL OR FORMAL RULES OF PROCEDURE. 12

13 14. IN THE EVENT THAT THE DEPARTMENT SHALL DENY THE APPLICATION FOR, 14 OR REVOKE OR SUSPEND ANY SUCH LICENSE, OR IMPOSE ANY FINE OR REPRIMAND, 15 ITS DETERMINATION SHALL BE IN WRITING AND OFFICIALLY SIGNED. THE 16 ORIGINAL OF SUCH DETERMINATIONS, WHEN SO SIGNED, SHALL BE FILED IN THE 17 OFFICE OF THE DEPARTMENT AND COPIES THEREOF SHALL BE MAILED TO THE 18 APPLICANT OR LICENSEE AND TO THE COMPLAINANT WITHIN TWO DAYS AFTER SUCH 19 FILING.

20 15. THE DEPARTMENT, ACTING BY THE OFFICE OR PERSON DESIGNATED TO 21 CONDUCT THE HEARING PURSUANT TO SUBDIVISION THIRTEEN OF THIS SECTION OR SUCH OTHER OFFICER OR PERSON IN THE DEPARTMENT AS THE SECRETARY OF 22 ΒY STATE MAY DESIGNATE, SHALL HAVE THE POWER TO SUSPEND THE LICENSE OF ANY 23 24 LICENSEE WHO HAS BEEN CONVICTED IN THIS STATE OR ANY OTHER STATE OR 25 TERRITORY OF A FELONY OR OF ANY MISDEMEANOR FOR A PERIOD NOT EXCEEDING 26 THIRTY DAYS PENDING A HEARING AND A DETERMINATION OF CHARGES MADE AGAINST HIM OR HER. IF SUCH HEARING IS ADJOURNED AT THE REQUEST OF THE 27 28 LICENSEE, OR BY REASON OF ANY ACT OR OMISSION BY HIM OR HER OR ON HIS OR HER BEHALF, SUCH SUSPENSION MAY BE CONTINUED FOR THE ADDITIONAL PERIOD 29 30 OF SUCH ADJOURNMENT.

THE ACTION OF THE DEPARTMENT IN GRANTING OR REFUSING TO GRANT OR TO RENEW A LICENSE UNDER THIS ARTICLE OR IN REVOKING OR SUSPENDING OR REFUSING TO REVOKE OR SUSPEND SUCH A LICENSE OR IMPOSING ANY FINE OR REPRIMAND SHALL BE SUBJECT TO REVIEW BY A PROCEEDING INSTITUTED UNDER ARTICLE SEVENTY-EIGHT OF THE CIVIL PRACTICE LAW AND RULES AT THE INSTANCE OF THE APPLICANT FOR SUCH LICENSE, THE HOLDER OF A LICENSE SO REVOKED, SUSPENDED, FINED OR REPRIMANDED.

FOR THE PURPOSE OF THIS ARTICLE, LICENSEES MAY BE HELD RESPONSIBLE 39 FOR STATEMENTS, REPRESENTATIONS, PROMISES OR ACTS OF THEIR EMPLOYEES OR 40 THEIR AGENTS WITHIN THE SCOPE OF THEIR AUTHORITY; PROVIDED, HOWEVER, THAT LICENSEES SHALL NOT BE HELD RESPONSIBLE FOR STATEMENTS, REPRESENTA-41 TIONS, PROMISES OR ACTS WHICH ARE CONTRARY TO INSTRUCTIONS OR WHICH 42 43 CONSTITUTE GROSS NEGLIGENCE OR INTENTIONAL TORTS UNLESS SPECIFICALLY AUTHORIZED BY THE LICENSEE. 48 (B) IN ADDITION TO ANY OTHER PENALTIES, IF A PERSON IS FOUND TO HAVE 49 COMMITTED REPEATED, MULTIPLE OR PERSISTENT VIOLATIONS OF ANY PROVISION 50 OF THIS ARTICLE, SUCH PERSON MAY BE RESPONSIBLE FOR THE COST OF THE 51 DEPARTMENT'S INVESTIGATION.

3 AS A CONDITION TO OBTAINING A LICENSE PURSUANT TO THIS ARTICLE, (B) 4 EVERY PROCESS SERVER APPLICANT WHO IS APPLYING FOR A LICENSE AND EMPLOYS 5 BETWEEN FIVE AND NINE INDIVIDUALS ENGAGED IN THE SERVICE OF PROCESS SHALL OBTAIN AND CONTINUE IN FULL FORCE AND EFFECT A BOND, CONTRACT OF 6 7 INDEMNITY, OR IRREVOCABLE LETTER OF CREDIT IN THE AMOUNT OF TWENTY-FIVE THOUSAND DOLLARS TO BE FILED WITH THE SECRETARY AS A CONDITION TO 8 9 OBTAINING A LICENSE PURSUANT TO THIS ARTICLE, EVERY PROCESS SERVER 10 APPLICANT WHO IS APPLYING FOR A LICENSE AND EMPLOYS BETWEEN TEN AND 11 TWENTY INDIVIDUALS ENGAGED IN THE SERVICE OF PROCESS SHALL OBTAIN AND 12 IN FULL FORCE AND EFFECT A BOND, CONTRACT OF INDEMNITY, OR CONTINUE IRREVOCABLE LETTER OF CREDIT IN THE AMOUNT OF FIFTY THOUSAND DOLLARS TO 13 14 BE FILED WITH THE SECRETARY;

15 (C) AS A CONDITION TO OBTAINING A LICENSE PURSUANT TO THIS ARTICLE, 16 EVERY PROCESS APPLICANT WHO IS APPLYING FOR A LICENSE AND EMPLOYS TWENTY 17 OR MORE INDIVIDUALS ENGAGED IN THE SERVICE OF PROCESS SHALL OBTAIN AND 18 CONTINUE IN FULL FORCE AND EFFECT A BOND, CONTRACT OF INDEMNITY, OR 19 IRREVOCABLE LETTER OF CREDIT, IN THE AMOUNT OF SEVENTY-FIVE THOUSAND 20 DOLLARS TO BE FILED WITH THE SECRETARY;

(D) SUCH SURETY BOND, CONTRACT OF INDEMNITY, OR IRREVOCABLE LETTER OF CREDIT SHALL BE CONDITIONED THAT THE APPLICANT WILL COMPLY WITH THIS ARTICLE, ARTICLE TWENTY-NINE-H, AND ARTICLE TWENTY-NINE-HH OF THIS CHAP-TER AND PAY ALL CIVIL PENALTIES, FINES, OR OTHER OBLIGATIONS IMPOSED BY THE SECRETARY OR A COURT OF LAW, INVESTIGATORY COSTS REQUIRED TO BE PAID, OR ANY FINAL JUDGMENT AGAINST THE LICENSEE PURSUANT TO SUCH ARTI-CLES;

(E) THE TOTAL LIABILITY IMPOSED ON THE SURETY BOND UNDER THIS SECTION

TOTAL CLAIMS IN EXCESS OF THE BOND AMOUNT, REGARDLESS OF THE NUMBER OR
NATURE OF CLAIMS MADE AGAINST THE BOND OR THE NUMBER OF YEARS THE BOND
REMAINED IN FORCE;

(F) ANY SURETY ISSUING A BOND PURSUANT TO THIS SECTION AND ANY LICENSEE SHALL BE REQUIRED TO PROVIDE THIRTY DAYS NOTICE TO THE SECRETARY
PRIOR TO THE EFFECTIVE DATE OF CANCELLATION OF THE BOND. THE FAILURE TO
MAINTAIN SUCH A BOND SHALL OPERATE TO REVOKE THE LICENSE OF THE PROCESS
SERVER UPON NOTICE AND HEARING.

(A) WHEREVER THERE SHALL BE A VIOLATION OF THIS ARTICLE, AN APPLI-CATION MAY BE MADE BY THE ATTORNEY GENERAL IN THE NAME OF THE PEOPLE OF 41 THE STATE OF NEW YORK TO A COURT OR JUSTICE HAVING JURISDICTION BY A 42 43 SPECIAL PROCEEDING TO ISSUE AN INJUNCTION, AND UPON NOTICE TO THE 44 DEFENDANT OF NOT LESS THAN FIVE DAYS, TO ENJOIN OR RESTRAIN THE CONTIN-45 UANCE OF SUCH VIOLATION; AND IF IT SHALL APPEAR TO THE SATISFACTION OF THE COURT OR JUSTICE THAT THE DEFENDANT HAS, IN FACT, VIOLATED THIS 46 47 SECTION, AN INJUNCTION MAY BE ISSUED BY SUCH COURT OR JUSTICE, ENJOINING 48 AND RESTRAINING ANY FURTHER VIOLATION, WITHOUT REQUIRING PROOF THAT ANY 49 PERSON HAS, IN FACT, BEEN INJURED OR DAMAGED THEREBY. IN ANY SUCH 50 PROCEEDING, THE COURT MAY MAKE ALLOWANCES TO THE ATTORNEY GENERAL AS PROVIDED IN PARAGRAPH SIX OF SUBDIVISION (A) OF SECTION EIGHTY-THREE 51 HUNDRED THREE OF THE CIVIL PRACTICE LAW AND RULES, AND DIRECT RESTITU-52 TION. WHENEVER THE COURT SHALL DETERMINE THAT A VIOLATION OF THIS 53 54 SECTION HAS OCCURRED, THE COURT MAY IMPOSE A CIVIL PENALTY OF NOT LESS 55 THAN ONE HUNDRED DOLLARS NOR MORE THAN TEN THOUSAND DOLLARS FOR EACH 56 VIOLATION. IN CONNECTION WITH ANY SUCH PROPOSED APPLICATION, THE ATTOR-

1 NEY GENERAL IS AUTHORIZED TO TAKE PROOF AND MAKE A DETERMINATION OF THE 2 RELEVANT FACTS AND TO ISSUE SUBPOENAS IN ACCORDANCE WITH THE CIVIL PRAC-3 TICE LAW AND RULES;

4 (B) ANY PERSON WHO HAS BEEN INJURED BY REASON OF ANY VIOLATION OF THIS 5 ARTICLE MAY BRING AN ACTION IN HIS OR HER OWN NAME TO ENJOIN SUCH UNLAW-6 OR PRACTICE, AN ACTION TO RECOVER HIS OR HER ACTUAL DAMAGES OR FUL ACT 7 ONE THOUSAND DOLLARS, WHICHEVER IS GREATER, OR BOTH SUCH ACTIONS. THE COURT MAY, IN ITS DISCRETION, INCREASE THE AWARD OF DAMAGES TO AN AMOUNT 8 NOT TO EXCEED THREE TIMES THE ACTUAL DAMAGES UP TO TEN THOUSAND DOLLARS, 9 10 IF THE COURT FINDS THE DEFENDANT WILLFULLY VIOLATED THIS ARTICLE. IN THE SUCCESSFUL ACTION TO ENFORCE THE FOREGOING LIABILITY, THE 11 CASE OF ANY COURT MAY AWARD THE COSTS OF THE ACTION TOGETHER WITH REASONABLE ATTOR-12 13 NEY'S FEES.

14 20. (A) THIS ARTICLE SHALL APPLY TO ALL PROCESS SERVERS, PROVIDED, 15 HOWEVER, THAT A POLITICAL SUBDIVISION MAY IMPOSE OTHER REQUIREMENTS THAT 16 ARE IN ADDITION TO THE MINIMUM STANDARDS SET FORTH IN THIS ARTICLE.

17 (B) THE PROVISIONS OF THIS ARTICLE SHALL NOT BE CONSTRUED TO LIMIT IN 18 ANY WAY THE AUTHORITY OF A POLITICAL SUBDIVISION TO ENACT, IMPLEMENT AND 19 CONTINUE TO ENFORCE LOCAL LAWS AND REGULATIONS GOVERNING PROCESS SERVERS 20 THAT WERE IN EFFECT PRIOR TO THE EFFECTIVE DATE OF THIS SECTION, OR TO 21 ENACT, IMPLEMENT AND ENFORCE ANY AMENDMENTS THERETO AFTER THE EFFECTIVE 22 DATE OF THIS SECTION.

23 S 3. Subdivision (e) of rule 3015 of the civil practice law and rules, 24 as amended by chapter 21 of the laws of 2013, is amended to read as 25 follows:

26 (e) License to do business. Where the plaintiff's cause of action against a consumer arises from the plaintiff's conduct of a business 27 which is required by state or local law to be licensed by the department 28 29 of consumer affairs of the city of New York, the Suffolk county department of consumer affairs, the Westchester county department of consumer 30 affairs/weight-measures, the county of Rockland, the county of Putnam or 31 the Nassau county department of consumer affairs, OR THE DEPARTMENT OF 32 33 STATE PURSUANT TO SECTION EIGHTY-NINE-U OF THE GENERAL BUSINESS LAW, the 34 complaint shall allege, as part of the cause of action, that plaintiff was duly licensed at the time of services rendered and shall contain the 35 name and number, if any, of such license and the governmental 36 agency 37 which issued such license. The failure of the plaintiff to comply with 38 this subdivision will permit the defendant to move for dismissal pursu-39 ant to paragraph seven of subdivision (a) of rule thirty-two hundred 40 eleven of this chapter.

S 4. This act shall take effect on the one hundred eightieth day after it shall have become a law; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.
