AN ACT to amend the insurance law, in relation to insurance coverage for substance abuse disorder services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph 30 of subsection (i) of section 3216 of the insurance law, as added by chapter 41 of the laws of 2014, is amended by 3 adding a new subparagraph (D) to read as follows:

- POLICY PROVIDING COVERAGE UNDER THIS PARAGRAPH SHALL INCLUDE FOR AT LEAST NINETY DAYS AT A REHABILITATION FACILITY; COVERAGE PROVIDED. HOWEVER, THAT ANY STAY IN A REHABILITATION FACILITY REQUIRED TO BE COVERED PURSUANT TO THIS PARAGRAPH SHALL REQUIRE THE PRESCRIPTION OF A DOCTOR.
- 9 2. Paragraph 6 of subsection (1) of section 3221 of the insurance 10 law is amended by adding a new subparagraph (D) to read as follows:
- (D) A POLICY PROVIDING COVERAGE UNDER THIS PARAGRAPH SHALL 12 COVERAGE FOR AT LEAST NINETY DAYS AT A REHABILITATION FACILITY; PROVIDED, HOWEVER, THAT ANY STAY IN A REHABILITATION FACILITY REQUIRED 13 14 BE COVERED PURSUANT TO THIS PARAGRAPH SHALL REQUIRE THE PRESCRIPTION 15 OF A DOCTOR.
- 16 S 3. Subsection (k) of section 4303 of the insurance law is amended by 17 adding a new paragraph 4 to read as follows:
- 18 (4) A POLICY PROVIDING COVERAGE UNDER THIS SUBSECTION SHALL INCLUDE 19 COVERAGE FOR AT LEAST NINETY DAYS AT A REHABILITATION FACILITY; PROVIDED, HOWEVER, THAT ANY STAY IN A REHABILITATION FACILITY 20 REOUIRED 21 TO BE COVERED PURSUANT TO THIS SUBSECTION SHALL REQUIRE THE PRESCRIPTION 22 OF A DOCTOR.
- 23 This act shall take effect on the ninetieth day after it shall S 4. have become a law and shall apply to any policy issued, amended, or 24 25 renewed on and after such effective date.
