- AN ACT to amend the labor law, in relation to general powers and duties of the commissioner of labor

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. Section 21 of the labor law is amended by adding a new 1 2 subdivision 15 to read as follows:
- 3 15. CATALOGUE OF WORKFORCE DEVELOPMENT FUNDING. (A) THE DEPARTMENT SHALL PUBLISH BY OCTOBER FIRST, TWO THOUSAND SIXTEEN AND UPDATE ANNUAL-4 LY, THEREAFTER, A CATALOGUE OF WORKFORCE DEVELOPMENT FUNDING PROGRAMS. 5 6 SUCH CATALOGUE SHALL INCLUDE ALL STATE AND FEDERAL FUNDING PROGRAMS THAT SUPPORT THE FOLLOWING SERVICES, INCLUDING, BUT NOT LIMITED TO: 7 8
 - (1) EMPLOYMENT COUNSELING;
 - (2) THE OBTAINMENT OF A HIGH SCHOOL DIPLOMA OR ITS EQUIVALENT;
 - (3) HIGHER EDUCATION LEADING TO A CAREER;
 - (4) SKILLS AND VOCATIONAL TRAINING;
 - (5) SKILLS DEVELOPMENT AND IMPROVEMENT;
