AN ACT to amend the judiciary law, in relation to compensation of judges

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

44 S 11. Notwithstanding any other provision of law to the contrary,  
 45 pursuant to the authority granted to the legislature under part E of  
 46 chapter 60 of the laws of 2015, the provisions of this act shall serve  
 47 to, nullify and supersede, in its entirety, the recommendations of the  
 48 commission on legislative, judicial and executive compensations relating  
 49 to the annual salaries of New York state judges within article 7-B of  
 50 the judiciary law.

51 S 12. This act shall take effect on the first of April next succeeding  
 52 the date on which it shall have become a law.
