AN ACT to amend the education law, in relation to conduct on school property

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 2803 to read as follows:

- S 2803. UNIFORM INCIDENT REPORTING SYSTEM REGARDING REMOVAL OF STUDENTS AND OTHER PERSONS FROM CLASSROOMS AND SCHOOL PROPERTY. 1. THE COMMISSIONER SHALL ESTABLISH A STATEWIDE UNIFORM INCIDENT REPORTING SYSTEM WHICH PUBLIC SCHOOL DISTRICTS, BOARDS OF COOPERATIVE EDUCATIONAL SERVICES AND COUNTY VOCATIONAL EDUCATION AND EXTENSION BOARDS SHALL FOLLOW.
- 9 2. THE UNIFORM INCIDENT REPORTING SYSTEM REGARDING REMOVAL OF STUDENTS 10 AND OTHER PERSONS FROM CLASSROOMS AND SCHOOL PROPERTY SHALL CREATE A 11 REGISTRY AND SHALL REOUIRE PUBLIC SCHOOL DISTRICTS, BOARDS OF COOPER-ATIVE EDUCATIONAL SERVICES AND COUNTY VOCATIONAL EDUCATION AND EXTENSION 12 BOARDS TO ANNUALLY REPORT TO THE COMMISSIONER IN A FORM AND BY A DATE 13 14 PRESCRIBED BY THE COMMISSIONER, THE FOLLOWING INFORMATION CONCERNING STUDENTS AND THE OTHER PERSONS WHO ARE REMOVED FROM CLASSROOMS 15 16 SCHOOL PROPERTY PURSUANT TO THIS ARTICLE:
- 17 A. THE NAME OF THE SCHOOL DISTRICT OR DISTRICTS IN WHICH THE REMOVAL 18 OF THE STUDENT OR STUDENTS OR OTHER PERSON OR PERSONS FROM A CLASSROOM 19 OR SCHOOL PROPERTY OCCURRED;
- 20 B. THE NAME OF THE TEACHER, THE NAME OF THE SCHOOL AND THE LOCATION OF 21 THE SCHOOL AT WHICH THE REMOVAL OCCURRED;
- 22 C. IF THE INDIVIDUAL REMOVED IS A STUDENT, THE AGE AND GRADE OF THE 23 STUDENT;
- 24 D. THE REASONS STATED BY THE TEACHER FOR THE REMOVAL;

- E. THE ACTION TAKEN BY THE SCHOOL IN RESPONSE TO THE INCIDENT;
- F. WHETHER ANY DISCIPLINARY ACTION WAS TAKEN AGAINST THE STUDENT, AND IF SO, THE TYPE OF DISCIPLINARY ACTION TAKEN AGAINST THE STUDENT;

G. BY JANUARY FIRST OF EACH YEAR, THE COMMISSIONER SHALL REPORT TO THE GOVERNOR, THE LEGISLATURE AND THE REGENTS CONCERNING THE PREVALENCE OF INCIDENTS INVOLVING REMOVAL FROM THE CLASSROOM. THE REPORT SHALL SUMMA-RIZE THE INFORMATION AVAILABLE FROM THE REGISTRY AND INCIDENT REPORTING 5 SYSTEM AND IDENTIFY SPECIFICALLY THE SCHOOLS AND SCHOOL DISTRICTS WITH THE LEAST AND THE GREATEST INCIDENCE OF INCIDENTS AND THE NAMES OF 7 TEACHERS AND NUMBER OF CLASSROOM REMOVALS INITIATED BY EACH SUCH INDI-VIDUAL TEACHER. THE REPORT SHALL ALSO, TO THE EXTENT POSSIBLE, RELATE THE RESULTS AVAILABLE FROM THE REGISTRY, TOGETHER WITH SUCH OTHER ANALY-9 10 SIS AND INFORMATION AS THE COMMISSIONER DETERMINES IS APPROPRIATE, TO THE EFFECTIVENESS OF CLASSROOM REMOVAL MEASURES UNDERTAKEN BY PARTIC-11 12 IPATING SCHOOLS AND SCHOOL DISTRICTS; AND

H. THE COMMISSIONER SHALL PROMULGATE REGULATIONS TO IMPLEMENT THE 13 14 PROVISIONS OF THIS SECTION AND TO ASSURE TO THE EXTENT PRACTICABLE THAT THE REPORTS USED BY SCHOOL DISTRICTS ARE UNIFORM AND COMPARABLE WITH 15 RESPECT TO THE TYPES OF INCIDENTS REPORTED AND THE RESPONSES OF THE 16 SCHOOLS AND SCHOOL DISTRICTS. IF THE REPORTS INDICATE A TEACHER HAS AN 17 UNUSUALLY LARGE NUMBER OF REMOVALS OR THE REASONS FOR SAME ARE UNSATIS-18 19 FACTORY, SUCH TEACHER SHALL BE SUBJECT TO APPROPRIATE ACTION BY THE COMMISSIONER. SUCH REGULATIONS SHALL PROVIDE FOR THE CONFIDENTIALITY OF 20 21 ALL PERSONALLY IDENTIFIABLE INFORMATION AND SHALL ENSURE THAT ANY PERSONALLY IDENTIFIABLE INFORMATION WHICH IS COLLECTED IS USED ONLY FOR ITS INTENDED PURPOSE. FURTHER, ANY INFORMATION COLLECTED UNDER THIS 23 SECTION SHALL BE PERPETUATED IN THE REGISTRY FOR FURTHER EVALUATION BY 24 25 THE COMMISSIONER.

26 S 2. This act shall take effect immediately.
