AN ACT to establish a report on arts and music education in elementary and secondary schools; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. 1. The commissioner of education shall: (a) create a procedure in which school district compliance with current arts education and
2 instruction requirements including visual arts, music, dance and theatre, hereinafter referred to in this act as "arts education instruction", as required by law and regulation in elementary and secondary
3 public schools is reported to the state education department by school
4 districts for the purposes of preparing the report provided for by
5 subdivision two of this section; and (b) provide suggestions on how the
6 current arts education instruction requirements could be improved or
7 enhanced.
8 2. The state education department shall prepare a report that must
9 include, but not be limited to, the following:
10 (a) how the state standards, including statutory and regulatory
11 requirements, for arts education instruction could be revised or altered
12 to better promote education and appreciation of the arts and music in
13 elementary and secondary schools;
14 (b) how the state standards, including statutory and regulatory
15 requirements, for arts education instruction could be revised or altered

8 3. On or before July 1, 2018, the commissioner of education shall
9 report to the governor, the temporary president of the senate, the
10 speaker of the assembly, and the chairs of the senate and assembly
11 committees on education the findings made based on the information
12 reported pursuant to subdivision one of this section including an analy-
13 sis and explanation of the data, and shall identify steps that should be
14 taken to ensure that all public schools are in compliance with arts
15 education instruction requirements in elementary and secondary grades
16 and examine, evaluate and make recommendations concerning the adequacy
17 of the current state standards for arts education and instruction for
18 elementary and secondary schools in the state. Such recommendations may
19 include but not be limited to revisions or alterations to the state
20 standards for arts education and instruction to better promote and
21 increase time devoted to providing such instruction.

22 S 2. This act shall take effect immediately, and shall expire and be
23 deemed repealed January 1, 2019 or on the one hundred eightieth day
24 after the report required by subdivisions two and three of section one
25 of this act is submitted to the governor, the temporary president of the
26 senate, the speaker of the assembly, and the chairs of the senate and
27 assembly committees on education, whichever shall be later; provided,
28 further, that the state education department shall notify the legisla-
29 tive bill drafting commission upon the submission of the report required
30 by subdivisions two and three of section one of this act to the gover-
31 nor, the temporary president of the senate, the speaker of the assembly,
32 and the chairs of the senate and assembly committees on education, in
33 order that the commission may maintain an accurate and timely effective
34 data base of the official text of the laws of the state of New York in
35 furtherance of effectuating the provisions of section 44 of the legisla-
36 tive law and section 70-b of the public officers law.
