AN ACT to amend the civil practice law and rules, in relation to consumer credit transactions

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Short title. This act shall be known and may be cited as the "consumer credit fairness act".
 - S 2. Subdivision 2 of section 213 of the civil practice law and rules, as amended by chapter 709 of the laws of 1988, is amended to read as follows:
- 2. an action upon a contractual obligation or liability, express or implied, except as provided in section two hundred thirteen-a OR TWO HUNDRED FOURTEEN-F of this article or article [2] TWO of the uniform commercial code or article [36-B] THIRTY-SIX-B of the general business law;
- 11 S 3. The civil practice law and rules is amended by adding a new 12 section 214-f to read as follows:
- S 214-F. CERTAIN ACTIONS ARISING OUT OF CONSUMER CREDIT TRANSACTIONS
 14 TO BE COMMENCED WITHIN THREE YEARS. AN ACTION ARISING OUT OF A CONSUMER
 15 CREDIT TRANSACTION WHERE A PURCHASER, BORROWER OR DEBTOR IS A DEFENDANT
 16 MUST BE COMMENCED WITHIN THREE YEARS, EXCEPT AS PROVIDED IN SECTION TWO
- 17 HUNDRED THIRTEEN-A OF THIS ARTICLE OR ARTICLE TWO OF THE UNIFORM COMMER-
- 18 CIAL CODE OR ARTICLE THIRTY-SIX-B OF THE GENERAL BUSINESS LAW. WHEN THE
- 19 PERIOD WITHIN WHICH AN ACTION MAY BE COMMENCED UNDER THIS SECTION HAS 20 EXPIRED, THE RIGHT TO COLLECT CONSUMER CREDIT DEBT IS EXTINGUISHED AS
- 21 WELL AS THE REMEDY.

FOR PURPOSES OF THIS SECTION, "THE RIGHT TO COLLECT CONSUMER CREDIT DEBT" SHALL MEAN ANY ATTEMPTS BY THE CREDITOR, THIRD PARTY PURCHASER, OR OTHER AUTHORIZED THIRD PARTY TO COLLECT SUCH DEBT INCLUDING, BUT NOT LIMITED TO, CALLS, MAIL OR OTHER ATTEMPTS TO COLLECT.

- S 4. The civil practice law and rules is amended by adding a new section 306-d to read as follows: 6
- 7 S 306-D. ADDITIONAL MAILING OF NOTICE IN AN ACTION ARISING OUT OF CONSUMER CREDIT TRANSACTION. 1. AT THE TIME OF FILING WITH THE CLERK OF THE PROOF OF SERVICE OF THE SUMMONS AND COMPLAINT IN AN ACTION ARISING 9
- 10 OUT OF A CONSUMER CREDIT TRANSACTION, THE PLAINTIFF SHALL SUBMIT TO THE
- CLERK A STAMPED ENVELOPE ADDRESSED TO THE DEFENDANT TOGETHER WITH A 11 WRITTEN NOTICE IN CLEAR TYPE OF NO LESS THAN TWELVE-POINT IN SIZE, IN 12
- BOTH ENGLISH AND SPANISH, AND CONTAINING THE FOLLOWING LANGUAGE: 13

THE FACE OF THE ENVELOPE SHALL BE ADDRESSED TO THE DEFENDANT AT THE ADDRESS AT WHICH PROCESS WAS SERVED, AND SHALL CONTAIN THE DEFENDANT'S 42 43 NAME, ADDRESS (INCLUDING APARTMENT NUMBER) AND ZIP CODE. THE FACE OF THE 44 ENVELOPE ALSO SHALL STATE THE APPROPRIATE CLERK'S OFFICE AS ITS RETURN 45 ADDRESS.
- 46 3. THE CLERK PROMPTLY SHALL MAIL TO THE DEFENDANT THE ENVELOPE CONTAINING THE ADDITIONAL NOTICE SET FORTH IN SUBDIVISION ONE OF THIS 47 SECTION. NO DEFAULT JUDGMENT BASED ON THE DEFENDANT'S FAILURE TO ANSWER 48 SHALL BE ENTERED UNLESS THERE HAS BEEN COMPLIANCE WITH THIS SECTION, AND 49 50 AT LEAST TWENTY DAYS HAVE ELAPSED FROM THE DATE OF MAILING BY THE CLERK.
- S 5. Subdivision (a) of section 3012 of the civil practice law and rules is amended to read as follows:

(a) Service of pleadings. The complaint may be served with the summons, EXCEPT THAT IN AN ACTION ARISING OUT OF A CONSUMER CREDIT TRANSACTION, THE COMPLAINT SHALL BE SERVED WITH THE SUMMONS. A subsequent pleading asserting new or additional claims for relief shall be served upon a party who has not appeared in the manner provided for service of a summons. In any other case, a pleading shall be served in the manner provided for service of papers generally. Service of an answer or reply shall be made within twenty days after service of the pleading to which it responds.

- S 6. Rule 3016 of the civil practice law and rules is amended by adding a new subdivision (j) to read as follows:
- (J) CONSUMER CREDIT TRANSACTIONS. IN AN ACTION ARISING OUT OF A CONSUMER CREDIT TRANSACTION WHERE A PURCHASER, BORROWER OR DEBTOR IS A DEFENDANT, THE CONTRACT OR OTHER WRITTEN INSTRUMENT ON WHICH THE ACTION IS BASED SHALL BE ATTACHED TO THE COMPLAINT AND THE FOLLOWING INFORMATION SHALL BE SET FORTH IN THE COMPLAINT:
 - 1. THE NAME OF THE ORIGINAL CREDITOR;
 - 2. THE LAST FOUR DIGITS OF THE ORIGINAL ACCOUNT NUMBER;
 - 3. THE DATE AND AMOUNT OF THE LAST PAYMENT;
- 4. IF THE COMPLAINT CONTAINS A CAUSE OF ACTION BASED ON AN ACCOUNT STATED, THE DATE THAT THE FINAL STATEMENT OF ACCOUNT WAS MAILED TO THE DEFENDANT;
- 5. AN ITEMIZATION OF THE AMOUNT SOUGHT, BY (I) PRINCIPAL; (II) FINANCE CHARGE OR CHARGES; (III) FEES IMPOSED BY THE ORIGINAL CREDITOR; (IV) COLLECTION COSTS; (V) ATTORNEY'S FEES; (VI) INTEREST; AND (VII) ANY OTHER FEES AND CHARGES. THE TERM "FINANCE CHARGE" MEANS A FINANCE CHARGE AS DEFINED IN REGULATION Z, 12 C.F.R. S 226.4.
- 6. WHETHER THE PLAINTIFF IS THE ORIGINAL CREDITOR. IF THE PLAINTIFF IS NOT THE ORIGINAL CREDITOR, THE COMPLAINT SHALL STATE (I) THE DATE ON WHICH THE DEBT WAS ASSIGNED TO THE PLAINTIFF; AND (II) THE NAME OF EACH PREVIOUS OWNER OF THE ACCOUNT AND THE DATE ON WHICH THE DEBT WAS ASSIGNED TO THAT OWNER.
- 7. ANY MATTERS REQUIRED TO BE STATED WITH PARTICULARITY PURSUANT TO RULE THREE THOUSAND FIFTEEN OF THIS ARTICLE.
- S 7. Subdivision (e) of rule 3211 of the civil practice law and rules, as amended by chapter 616 of the laws of 2005, is amended to read as follows:
- (e) Number, time and waiver of objections; motion to plead over. At any time before service of the responsive pleading is required, a party may move on one or more of the grounds set forth in subdivision (a) OF THIS SECTION, and no more than one such motion shall be permitted. Any objection or defense based upon a ground set forth in paragraphs one, three, four, five and six of subdivision (a) OF THIS SECTION is waived unless raised either by such motion or in the responsive pleading. A motion based upon a ground specified in paragraph two, seven or ten of subdivision (a) OF THIS SECTION may be made at any subsequent time or in later pleading, if one is permitted; IN ANY ACTION OTHER THAN AN ACTION ARISING OUT OF A CONSUMER CREDIT TRANSACTION WHERE A PURCHASER, BORROWER OR DEBTOR IS A DEFENDANT, an objection that the summons and complaint, summons with notice, or notice of petition and petition was properly served is waived if, having raised such an objection in a pleading, the objecting party does not move for judgment on that ground within sixty days after serving the pleading, unless the court extends the time upon the ground of undue hardship. The foregoing sentence shall not apply in any proceeding under subdivision one or two of section seven hundred eleven of the real property actions and proceedings law.

The papers in opposition to a motion based on improper service shall contain a copy of the proof of service, whether or not previously filed. An objection based upon a ground specified in paragraph eight or nine of subdivision (a) OF THIS SECTION is waived if a party moves on any of the grounds set forth in subdivision (a) OF THIS SECTION without raising such objection or if, having made no objection under subdivision (a) OF THIS SECTION, he or she does not raise such objection in the responsive pleading.

- S 8. Subdivision (f) of section 3215 of the civil practice law and rules, as amended by chapter 453 of the laws of 2006, is amended and a new subdivision (j) is added to read as follows:
- (f) Proof. On any application for judgment by default, the applicant shall file proof of service of the summons and the complaint, or a 12 13 14 summons and notice served pursuant to subdivision (b) of rule 305 or 15 subdivision (a) of rule 316 of this chapter, and proof of the facts constituting the claim, the default and the amount due by affidavit made by the party, or where the state of New York is the plaintiff, by affi-16 17 davit made by an attorney from the office of the attorney general who 18 19 has or obtains knowledge of such facts through review of state records or otherwise. Where a verified complaint has been served, it may be used 20 as the affidavit of the facts constituting the claim and the amount due; 21 22 such case, an affidavit as to the default shall be made by the party 23 or the party's attorney. IN AN ACTION ARISING OUT OF A CONSUMER CREDIT 24 TRANSACTION, IF THE PLAINTIFF IS NOT THE ORIGINAL CREDITOR, THE APPLI-25 CANT SHALL INCLUDE: (I) AN AFFIDAVIT BY THE ORIGINAL CREDITOR 26 FACTS CONSTITUTING THE DEBT, THE DEFAULT IN PAYMENT, THE SALE OR ASSIGN-MENT OF THE DEBT, AND THE AMOUNT DUE AT THE TIME OF SALE OR ASSIGNMENT; 27 28 (II) FOR EACH SUBSEQUENT ASSIGNMENT OR SALE OF THE DEBT TO ANOTHER ENTI-29 TY, AN AFFIDAVIT OF SALE OF THE DEBT BY THE DEBT SELLER, COMPLETED 30 SELLER OR ASSIGNOR; AND (III) AN AFFIDAVIT OF A WITNESS OF THE PLAINTIFF, WHICH INCLUDES A CHAIN OF TITLE OF THE DEBT, COMPLETED BY THE 31 32 PLAINTIFF OR PLAINTIFF'S WITNESS. When jurisdiction is based 33 attachment of property, the affidavit must state that an order of attachment granted in the action has been levied on the property of the 34 35 defendant, describe the property and state its value. Proof of mailing 36 the notice required by subdivision (g) of this section, where applica-37 ble, shall also be filed.
 - (J) AFFIDAVIT. A REQUEST FOR A DEFAULT JUDGMENT ENTERED BY THE CLERK, MUST BE ACCOMPANIED BY AN AFFIDAVIT BY THE DEBT COLLECTOR (WHO MAY BE THE PLAINTIFF OR PLAINTIFF'S ATTORNEY) STATING THAT AFTER REASONABLE INQUIRY, HE OR SHE HAS REASON TO BELIEVE THAT THE STATUTE OF LIMITATIONS HAS NOT EXPIRED.
 - S 9. The civil practice law and rules is amended by adding a new section 7515 to read as follows:
- 45 S 7515. CONFIRMATION OF AN AWARD BASED ON A CONSUMER CREDIT TRANS-46 IN ANY PROCEEDING UNDER SECTION SEVEN THOUSAND FIVE HUNDRED TEN ACTION. 47 OF THIS ARTICLE TO CONFIRM AN AWARD BASED ON A CONSUMER CREDIT 48 THE PARTY SEEKING TO CONFIRM THE AWARD SHALL PLEAD THE ACTUAL 49 TERMS AND CONDITIONS OF THE AGREEMENT TO ARBITRATE. THE PARTY SHALL 50 PETITION (1) THE AGREEMENT TO ARBITRATE; (2) THE DEMAND TO ITS 51 FOR ARBITRATION OR NOTICE OF PROOF INTENTION TO ARBITRATE, WITH52 SERVICE; AND (3) THE ARBITRATION AWARD, WITH PROOF OF SERVICE. IF THE 53 AWARD DOES NOT CONTAIN A STATEMENT OF THE CLAIMS SUBMITTED FOR 54 OF THE CLAIMS RULED UPON BY THE ARBITRATOR, AND OF THE CALCU-55 LATION OF FIGURES USED BY THE ARBITRATOR IN ARRIVING AT THE AWARD, 56 PETITION SHALL CONTAIN SUCH A STATEMENT. THE COURT SHALL NOT GRANT THE

CONFIRMATION OF AN AWARD BASED ON A CONSUMER CREDIT TRANSACTION UNLESS THE PARTY SEEKING TO CONFIRM THE AWARD HAS COMPLIED WITH THIS SECTION.

S 10. This act shall take effect on the first of January next succeeding the date on which it shall have become a law, except that section three of this act shall take effect on the one hundred eightieth day after this act shall have become a law.
