RANZENHOFER -- read twice and ordered printed, and when printed to be committed to the Committee on Environmental Conservation -- reported favorably from said committee, ordered to first and second report, ordered to a third reading, passed by Senate and delivered to the Assembly, recalled, vote reconsidered, restored to third reading, amended and ordered reprinted, retaining its place in the order of third reading

AN ACT to amend the environmental conservation law, in relation to authorizing hunting in the county of Genesee; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the
2 environmental conservation law is amended by adding a new item (j) to
3 read as follows:

4 (J) THE COUNTY OF	DEER, THE FIRST SATURDAY	PISTOL, SHOTGUN,
5 GENESEE	AFTER NOVEMBER 15	CROSSBOW, MUZZLE
6	THROUGH FIRST SUNDAY	LOADING FIREARM,
7	AFTER DECEMBER 7	RIFLE OR LONG BOW

8 S 2. Item (f) of paragraph a of subdivision 2 of section 11-0907 of

10 laws of 2014, is amended to read as follows:

4 a. the amendments to paragraph a of subdivision 2 of section 11-0907
5 of the environmental conservation law made by section one of this act
6 shall be subject to the expiration and reversion of such paragraph
7 pursuant to section 13 of chapter 600 of the laws of 1993, as amended;
8 b. the amendments to paragraph a of subdivision 2 of section 11-0907
9 of the environmental conservation law made by section two of this act
10 shall be subject to the expiration and reversion of such paragraph
11 pursuant to section 13 of chapter 600 of the laws of 1993, as amended,
12 and shall not affect the expiration of such item, pursuant to section 3
13 of chapter 142 of the laws of 2014, as amended; and
14 c. nothing contained in this act shall be construed so as to extend
15 the provisions of this act beyond October 1, 2017, when upon such date
16 this act shall expire and the provisions contained herein shall be
17 deemed repealed.
