- AN ACT to amend the education law, in relation to providing a live webcast for meetings of the board of regents

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 204-a 2 to read as follows:

3 S 204-A. WEBCASTING MEETINGS. THE ENTIRETY OF EACH MEETING OF THE 4 REGENTS SHALL BE LIVE WEBCAST AND BE MADE AVAILABLE TO THE PUBLIC ON THE DEPARTMENT'S WEBSITE PRIOR TO THE START OF EACH MEETING, AND ARCHIVED ON 5 б THE DEPARTMENT'S WEBSITE, FOR A PERIOD OF NO LESS THAN TWO YEARS, WITHIN 7 TWENTY-FOUR HOURS OF THE ADJOURNMENT OF THE LAST MEETING. THE DEPART-MENT SHALL PROVIDE NOTICE TO THE PUBLIC, VIA THE DEPARTMENT'S WEBSITE, 8 9 OF THE AVAILABILITY OF THE LIVE WEBCAST OF SUCH MEETING AND SHALL NOTIFY 10 EACH SUPERINTENDENT OF A SCHOOL DISTRICT AND EACH DISTRICT SUPERINTEN-11 DENT OF THE BOARD OF COOPERATIVE EDUCATIONAL SERVICES MONTHLY OF THE 12 UPCOMING MEETING OF THE REGENTS AND PROVIDE INFORMATION ON THE AVAIL-13 ABILITY OF AND WHERE TO OBTAIN THE LIVE WEBCAST OF SUCH MEETING ON THE 14 DEPARTMENT'S WEBSITE. THE REQUIREMENT TO LIVE WEBCAST THE ENTIRETY OF EACH MEETING SHALL NOT INCLUDE EXECUTIVE SESSIONS. 15

16 S 2. This act shall take effect on the ninetieth day after it shall 17 have become a law.
