PARKER, ADDABBO, AVELLA, HASSELL-THOMPSON, LATIMER -- read twice and ordered printed, and when printed to be committed to the Committee on Veterans, Homeland Security and Military Affairs -- recommitted to the Committee on Veterans, Homeland Security and Military Affairs in accordance with Senate Rule 6, sec. 8 -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee

AN ACT to amend the executive law, in relation to personal information obtained from veterans or family members of veterans receiving services from the state and political subdivisions thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The executive law is amended by adding a new section 354-e
2 to read as follows:
3 S 354-E. USE OF PERSONAL INFORMATION OBTAINED FROM VETERANS OR FAMILY
4 MEMBERS OF VETERANS RECEIVING SERVICES FROM THE STATE AND POLITICAL
5 SUBDIVISIONS THEREOF. 1. DEPARTMENTS, DIVISIONS, BUREAUS, BOARDS,
6 COMMISSIONS AND AGENCIES OF THE STATE AND POLITICAL SUBDIVISIONS THERE-
7 OF, WHICH PROVIDE ASSISTANCE, TREATMENT, COUNSELING, CARE, SUPERVISION
8 OR CUSTODY IN SERVICE AREAS INVOLVING HEALTH, MENTAL HEALTH, FAMILY
9 SERVICES, CRIMINAL JUSTICE OR EMPLOYMENT SHALL BE REQUIRED TO SOLICIT
10 INFORMATION ON WHETHER THEIR CUSTOMER OR CLIENT IS A VETERAN AS DEFINED
11 IN SECTION EIGHTY-FIVE OF THE CIVIL SERVICE LAW OR FAMILY MEMBER OF A
12 VETERAN. ANY NEW FORMS CREATED AFTER THE EFFECTIVE DATE OF THIS SECTION
13 SHALL CONTAIN THE FOLLOWING QUESTIONS: "HAVE YOU SERVED IN THE UNITED
14 STATES ARMED FORCES?" "HAS SOMEONE IN YOUR FAMILY SERVED IN THE UNITED
15 STATES MILITARY?"
16 2. INDIVIDUALS IDENTIFYING THEMSELVES AS HAVING SERVED IN THE MILITARY
17 OR A FAMILY MEMBER SHALL BE ADVISED THAT THE DIVISION OF VETERANS'
18 AFFAIRS AND LOCAL VETERANS SERVICE AGENCIES ESTABLISHED PURSUANT TO
19 SECTION THREE HUNDRED FIFTY-SEVEN OF THIS ARTICLE PROVIDE ASSISTANCE TO

7 S 2. This act shall take effect on the ninetieth day after it shall
8 have become a law; provided that any rules or regulations necessary for
9 the implementation of this act on its effective date shall be promulgat-
10 ed on or before such date.
