AN ACT to amend the vehicle and traffic law, in relation to surcharges for the use of mobile telephones or the use of portable electronic devices while in a work area or school zone

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Section 1225-c of the vehicle and traffic law is amended by adding a new subdivision 5 to read as follows:
- 5. (A) A VIOLATION OF SUBDIVISION TWO OF THIS SECTION WHILE IN A WORK AREA OR SCHOOL ZONE SHALL BE A TRAFFIC INFRACTION AND SHALL BE PUNISHABLE BY A SURCHARGE OF ONE HUNDRED DOLLARS WHICH SHALL BE IN ADDITION TO THE AMOUNTS PRESCRIBED IN SUBDIVISION FOUR OF THIS SECTION.
 - (B) FOR PURPOSES OF THIS SUBDIVISION:

- 8 I. "WORK AREA" SHALL MEAN THAT PART OF A HIGHWAY BEING USED OR OCCU-9 PIED FOR THE CONDUCT OF HIGHWAY WORK, WITHIN WHICH WORKERS, VEHICLES, 10 EQUIPMENT, MATERIALS, SUPPLIES, EXCAVATIONS, OR OTHER OBSTRUCTIONS ARE 11 PRESENT.
 - II. "SCHOOL ZONE" SHALL MEAN THE DISTANCE ALONG A HIGHWAY PASSING A SCHOOL BUILDING, ENTRANCE OR EXIT OF A SCHOOL ABUTTING ON THE HIGHWAY FOR WHICH A SCHOOL SIGN (S1-1) HAS BEEN POSTED PURSUANT TO THIS CHAPTER AND IN COMPLIANCE WITH THE MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES MAINTAINED PURSUANT TO SECTION SIXTEEN HUNDRED EIGHTY OF THIS CHAPTER.
 - S 2. Section 1225-d of the vehicle and traffic law is amended by adding a new subdivision 7 to read as follows:
- 7. (A) A VIOLATION OF THIS SECTION WHILE IN A WORK AREA OR SCHOOL ZONE SHALL BE A TRAFFIC INFRACTION AND SHALL BE PUNISHABLE BY A SURCHARGE OF ONE HUNDRED DOLLARS WHICH SHALL BE IN ADDITION TO THE AMOUNTS PRESCRIBED IN SUBDIVISION SIX OF THIS SECTION.
 - (B) FOR PURPOSES OF THIS SUBDIVISION:

I I. "WORK AREA" SHALL MEAN THAT PART OF A HIGHWAY BEING USED OR OCCU-2 PIED FOR THE CONDUCT OF HIGHWAY WORK, WITHIN WHICH WORKERS, VEHICLES, 3 EQUIPMENT, MATERIALS, SUPPLIES, EXCAVATIONS, OR OTHER OBSTRUCTIONS ARE 4 PRESENT.

- II. "SCHOOL ZONE" SHALL MEAN THE DISTANCE ALONG A HIGHWAY PASSING A SCHOOL BUILDING, ENTRANCE OR EXIT OF A SCHOOL ABUTTING ON THE HIGHWAY FOR WHICH A SCHOOL SIGN (S1-1) HAS BEEN POSTED PURSUANT TO THIS CHAPTER AND IN COMPLIANCE WITH THE MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES MAINTAINED PURSUANT TO SECTION SIXTEEN HUNDRED EIGHTY OF THIS CHAPTER.
- 10 S 3. This act shall take effect on the sixtieth day after it shall 11 have become a law.
