AN ACT to amend the penal law, in relation to assault of certain persons providing direct patient care

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 120.05 of the penal law is amended by adding two 2 new subdivisions 3-c and 11-c to read as follows:
- 3 PREVENT AN INTENT TO EMPLOYEE PROVIDING DIRECT PATIENT WITH CARE, WHO IS NOT A NURSE PURSUANT TO TITLE EIGHT OF THE EDUCATION 5 WHOSE PRINCIPAL EMPLOYMENT RESPONSIBILITY IS TO CARRY OUT DIRECT PATIENT 6 CARE FOR ONE OR MORE PATIENTS IN ANY HOSPITAL, NURSING HOME, RESIDENTIAL 7 HEALTH CARE FACILITY, GENERAL HOSPITAL, GOVERNMENT AGENCY INCLUDING ANY 8 CHRONIC DISEASE HOSPITAL, MATERNITY HOSPITAL, OUTPATIENT DEPARTMENT, CENTER OR SURGICAL CENTER UNDER ARTICLE TWENTY-EIGHT OF THE 9 EMERGENCY 10 PUBLIC HEALTH LAW, FROM PERFORMING A LAWFUL DUTY, HE OR SHE CAUSES PHYS-ICAL INJURY TO SUCH EMPLOYEE PROVIDING DIRECT PATIENT CARE; OR 11
 - WITH INTENT TO CAUSE PHYSICAL INJURY TO AN 11-C. EMPLOYEE PROVIDING PATIENT CARE, WHO IS NOT A NURSE PURSUANT TO TITLE EIGHT OF THE EDUCATION LAW, WHOSE PRINCIPAL EMPLOYMENT RESPONSIBILITY IS TO CARRY OUT DIRECT PATIENT CARE FOR ONE OR MORE PATIENTS IN ANY HOSPITAL, RESIDENTIAL HEALTH CARE FACILITY, GENERAL HOSPITAL, GOVERNMENT AGENCY INCLUDING ANY CHRONIC DISEASE HOSPITAL, MATERNITY HOSPITAL, OUTPATIENT DEPARTMENT, EMERGENCY CENTER OR SURGICAL CENTER UNDER ARTICLE TWENTY-EIGHT OF THE PUBLIC HEALTH LAW, HE OR SHE CAUSES PHYSICAL INJURY TO SUCH EMPLOYEE PROVIDING DIRECT PATIENT CARE WHILE SUCH EMPLOYEE
- 20 TO SUCH EMPLOYEE PROVIDING DIRECT PATIENT 21 PERFORMING A LAWFUL DUTY; OR
