- AN ACT to amend the real property tax law, in relation to exempting un-remarried spouses of paid or volunteer fire fighters, ambulance workers or police officers who have fallen in the line of duty from all or a portion of their real property taxes on their primary residence

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 466-h of the real property tax law, as added by 1 2 chapter 305 of the laws of 2006, is amended to read as follows: 3 S 466-h. Un-remarried spouses of deceased volunteer OR PAID firefight-4 ers [or volunteer], ambulance workers OR POLICE OFFICERS. ment or incorporated voluntary ambulance service] as an un-remarried spouse of a deceased enrolled member of such incorporated [volunteer] 1 2 fire company, fire department [or], incorporated [voluntary] ambulance 3 4 service OR POLICE DEPARTMENT, and

5 2. such deceased [volunteer had been an enrolled member for at least twenty years] MEMBER DIED IN THE LINE OF DUTY, and б
