AN ACT to amend the mental hygiene law, in relation to enacting the "skills for direct support professional jobs for the developmentally disabled act"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. This act shall be known and may be cited as the "skills for  
2     direct support professional jobs for the developmentally disabled act".  
3     S 2. The mental hygiene law is amended by adding a new section 13.42  
4     to read as follows:  
5     S 13.42 REPORT ON WORKFORCE NEEDS AND CREDENTIAL PRODUCTION.  
6     1. TO THE EXTENT PRACTICABLE WITHIN AVAILABLE RESOURCES AND SUBJECT TO  
7     THE AVAILABILITY OF DATA CURRENTLY COLLECTED BY AND ACCESSIBLE TO THE  
8     OFFICE, THE OFFICE, IN CONSULTATION WITH THE DEPARTMENT OF LABOR, THE  
9     DEPARTMENT OF EDUCATION, AND ANY OTHER ENTITY THE OFFICE DEEMS APPROPRI-  
10    ATE, SHALL PRODUCE A REPORT REGARDING STATE WORKFORCE NEED PROJECTIONS  
11    AND CREDENTIAL PRODUCTION. THE REPORT SHALL INCLUDE, BUT NOT BE LIMITED  
12    TO:  
13    (A) THE STATE'S CURRENT AND ANTICIPATED WORKFORCE NEEDS OVER THE NEXT  
14    FIVE YEARS, THE NUMBER OF DEGREES, CERTIFICATES, AND OTHER CREDENTIALS  
15    THAT PUBLIC AND PRIVATE INSTITUTIONS OF HIGHER EDUCATION, PRIVATE OCCU-  
16    PATIONAL SCHOOLS, LOCAL COMMUNITY COLLEGES, AND AREA VOCATIONAL SCHOOLS  
17    EXPECT TO ISSUE IN SIMILAR FIELDS FOR THE PURPOSE OF PERFORMING A  
18    COMPARISON ANALYSIS;  
19    (B) TO THE EXTENT PROVIDED BY SOURCES EXTERNAL TO THE DEPARTMENT,  
20    INDICATE THE STATE'S ANTICIPATED NUMBER OF DEGREES, CERTIFICATES, AND

1 OTHER CREDENTIALS THAT HIGH SCHOOL VOCATIONAL PROGRAMS, APPRENTICESHIP  
2 PROGRAMS, AND OTHER PUBLIC OR PRIVATE WORKFORCE TRAINING PROGRAMS EXPECT  
3 TO ISSUE IN SIMILAR FIELDS;

4 (C) IDENTIFY ANY WORKFORCE NEEDS, INCLUDING AREAS OF SPECIALIZATION  
5 WITHIN A PARTICULAR VOCATION, THAT MAY NOT BE MET BY THE EDUCATION,  
6 TRAINING, AND APPRENTICESHIP PROGRAMS; AND

7 (D) IDENTIFY INSTITUTIONS, PUBLIC OR PRIVATE, THAT MAY MEET PROJECTED  
8 WORKFORCE NEEDS.

9 2. THE OFFICE, BY JANUARY FIRST, TWO THOUSAND EIGHTEEN, SHALL PROVIDE  
10 A COPY OF THE REPORT TO THE MENTAL HEALTH AND DEVELOPMENTAL DISABILITIES  
11 COMMITTEE OF THE SENATE AND ASSEMBLY OR ANY SUCCESSOR COMMITTEE, AND TO  
12 THE GOVERNOR.

13 S 3. This act shall take effect immediately.
