AN ACT to amend the vehicle and traffic law, in relation to the issuance of distinctive plates bearing the words "Cure Parkinson's Disease", and to amend the state finance law, in relation to establishing the "Cure Parkinson's Disease Trust Fund"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 404-x to read as follows:

- S 404-X. DISTINCTIVE "CURE PARKINSON'S DISEASE" LICENSE PLATES. 1. ANY PERSON RESIDING IN THIS STATE SHALL UPON REQUEST BE ISSUED A DISTINCTIVE LICENSE PLATE BEARING THE WORDS "CURE PARKINSON'S DISEASE". APPLICATION FOR SUCH LICENSE PLATE SHALL BE FILED WITH THE COMMISSIONER
- IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.

  2. ANY DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED IN THE SAME MANNER AS OTHER NUMBER PLATES UPON THE PAYMENT OF THE REGULAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS
- 11 ARTICLE PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE OF 12 TWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATE. TWENTY DOLLARS OF
- 12 IWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATE. IWENTY DOLLARS OF 13 EACH SUCH TWENTY-FIVE DOLLAR ANNUAL SERVICE CHARGE SHALL BE DEPOSITED TO
- 13 EACH SUCH INENTI-FIVE DOLLAR ANNUAL SERVICE CHARGE SHALL BE DEPOSITED TO 14 THE CREDIT OF THE CURE PARKINSON'S DISEASE TRUST FUND ESTABLISHED PURSU-
- 15 ANT TO SECTION NINETY-NINE-W OF THE STATE FINANCE LAW AND SHALL BE USED 16 BY NEW YORK STATE UNIVERSITY PARKINSON'S DISEASE RESEARCH HOSPITALS FOR
- 17 RESEARCH AND EDUCATION PROGRAMS APPROVED BY THE COMMISSIONER OF HEALTH.
- 18 PROVIDED, HOWEVER THAT ONE YEAR AFTER THIS SECTION SHALL TAKE EFFECT,

- S 2. Section 508 of the vehicle and traffic law is amended by adding a new subdivision 6 to read as follows:
- THE COMMISSIONER IS DIRECTED TO DEVELOP LICENSE APPLICATION AND RENEWAL FORMS WHICH SHALL SOLICIT A VOLUNTARY ONE DOLLAR DONATION FROM PERSONS APPLYING FOR OR RENEWING A DRIVER'S LICENSE AT THE TIME OF SUCH APPLICATION OR RENEWAL. ANY MONEYS COLLECTED PURSUANT TO THIS SUBDIVI-SION SHALL BE DEPOSITED IN THE CURE PARKINSON'S DISEASE TRUST FUND ESTABLISHED PURSUANT TO SECTION NINETY-NINE-W OF THE STATE FINANCE LAW.
- S 3. The state finance law is amended by adding a new section 99-w to read as follows:
- S 99-W. CURE PARKINSON'S DISEASE TRUST FUND. 1. THERE IS HEREBY ESTAB-15 LISHED IN THE JOINT CUSTODY OF THE COMMISSIONER OF TAXATION AND FINANCE AND THE COMPTROLLER, A SPECIAL FUND TO BE KNOWN AS THE "CURE PARKINSON'S DISEASE TRUST FUND".
  - 2. SUCH FUND SHALL CONSIST OF ALL REVENUES RECEIVED PURSUANT PROVISIONS OF SECTION FOUR HUNDRED FOUR-X OF THE VEHICLE AND TRAFFIC LAW AND ALL OTHER MONEYS APPROPRIATED, CREDITED, OR TRANSFERRED THERETO FROM FUND OR SOURCE PURSUANT TO LAW. NOTHING CONTAINED IN THIS OTHER SECTION SHALL PREVENT THE STATE FROM RECEIVING GRANTS, GIFTS OR BEQUESTS FOR THE PURPOSES OF THE FUND AS DEFINED IN THIS SECTION AND DEPOSITING THEM INTO THE FUND ACCORDING TO LAW.
  - MONIES OF THE FUND SHALL BE EXPENDED ONLY FOR PARKINSON'S DISEASE RESEARCH AND EDUCATION PROJECTS APPROVED BY THE COMMISSIONER OF HEALTH, TO PROVIDE GRANTS TO NEW YORK STATE UNIVERSITY PARKINSON'S DISEASE RESEARCH HOSPITALS FOR THE PURPOSE OF RESEARCHING AND PROMOTING A CURE FOR PARKINSON'S DISEASE.
- MONIES SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF 30 31 THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE COMMISSIONER 32 OF HEALTH.
- 33 TO THE EXTENT PRACTICABLE, THE COMMISSIONER OF HEALTH SHALL ENSURE THAT ALL MONIES RECEIVED DURING A FISCAL YEAR ARE EXPENDED PRIOR TO THE 34 END OF THAT FISCAL YEAR. 35
- S 4. This act shall take effect on the one hundred eightieth day after 36 37 shall have become a law provided, however, that the addition, amend-38 ment and/or repeal of any rule or regulation necessary for the implemen-39 tation of this act on its effective date is authorized to be made and completed on or before such date. 40
