AN ACT to amend the vehicle and traffic law, in relation to performance of illegal maneuvers while operating a motorcycle

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The vehicle and traffic law is amended by adding a new 1 2 section 1254 to read as follows:
  - S 1254. PERFORMANCE OF AN ILLEGAL MANEUVER WHILE OPERATING A MOTORCY-(A) "ILLEGAL MANEUVER" SHALL MEAN ANY MANEUVER PERFORMED BY THE CLE. OPERATOR OF A MOTORCYCLE WHICH REQUIRES THE FRONT OR REAR WHEEL OF MOTORCYCLE TO LEAVE CONTACT WITH THE ROAD, OR ANY MANEUVER DESCRIBED IN SUBDIVISIONS (B) AND (C) OF SECTION TWELVE HUNDRED FIFTY-TWO THIS ILLEGAL MANEUVER SHALL NOT MEAN A MANEUVER PERFORMED BY A MOTORCYCLE WITH A SIDE PASSENGER TRUCK ATTACHMENT, INWHICH SIDE THE TRUCK LEAVES THE ROAD IN THE COURSE OF TAKING A TURN.
- (B) AN OPERATOR OF A MOTORCYCLE THAT PERFORMS AN ILLEGAL MANEUVER THAT 11 RESULTS IN PROPERTY DAMAGE OR BODILY HARM OF ANOTHER SHALL BE PUNISHABLE 12 13 BY A FINE NOT TO EXCEED TWENTY-FIVE HUNDRED DOLLARS AND THE AUTOMATIC REVOCATION OF THE OPERATOR'S LICENSE AND REGISTRATION FOR A PERIOD OF 14 15 ONE YEAR.
  - (C) AN OPERATOR OF A MOTORCYCLE THAT PERFORMS AN ILLEGAL MANEUVER THAT RESULTS IN PROPERTY DAMAGE OR BODILY HARM OF ANOTHER WITHIN EIGHTEEN MONTHS OF A PRIOR CONVICTION WHERE THE VIOLATOR PERFORMED AN ILLEGAL PROPERTY DAMAGE OR BODILY HARM OF ANOTHER, MANEUVER THAT RESULTED INSHALL BE PUNISHABLE BY THE FORFEITURE OF THE OPERATOR'S MOTORCYCLE AND AUTOMATIC REVOCATION OF THE OPERATOR'S LICENSE AND REGISTRATION FOR A PERIOD OF TWO YEARS.

part B of chapter 55 of the laws of 2014, are amended and two new subparagraphs (xiv) and (xv) are added to read as follows:

a second or subsequent conviction of a violation of section twelve hundred twenty-five-c or section twelve hundred twenty-five-d of this chapter committed where such person is the holder of a probationary license, as defined in subdivision four of section five hundred one of this title, at the time of the commission of such violation and such second or subsequent violation was committed within six months following the restoration or issuance of such probationary license; [or]

of a second or subsequent conviction of a violation of section twelve hundred twenty-five-c or section twelve hundred twenty-five-d of this chapter committed where such person is the holder of a class DJ or MJ learner's permit or a class DJ or MJ license at the time of the commission of such violation and such second or subsequent violation was committed within six months following the restoration of such permit or license[.];

(XIV) OF A VIOLATION OF SUBDIVISION (B) OF TWELVE SECTION HUNDRED CHAPTER SHALL RESULT IN A LICENSE AND REGISTRATION FIFTY-FOUR OF THIS REVOCATION OF ONE YEAR; OR

(XV) OF A SECOND VIOLATION OF SUBDIVISION (B) OF SECTION TWELVE 21 FIFTY-FOUR OF THIS CHAPTER SHALL RESULT IN A LICENSE AND REGIS-TRATION REVOCATION OF TWO YEARS. 22

23 S 3. This act shall take effect on the one hundred sixtieth day after 24 it shall have become a law.
