AN ACT to amend the executive law and the general business law, in relation to telecommunication service security

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The executive law is amended by adding a new section 719 to 2 read as follows:

S 719. SECURITY REPORT OF TELECOMMUNICATIONS ASSETS. THE NEW YORK STATE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, IN COOPERATION WITH THE DIVISION OF STATE POLICE, SHALL PERFORM AN INVESTIGATION AND, ON OR BEFORE APRIL FIRST, TWO THOUSAND SIXTEEN, SHALL ISSUE A REPORT TO THE GOVERNOR, THE TEMPORARY PRESIDENT OF THE SENATE, AND THE SPEAKER OF THE ASSEMBLY, ON TELECOMMUNICATION SECURITY IN NEW YORK STATE. SUCH INVESTIGATION AND REPORT SHALL EXAMINE THE FACILITIES AND OPERATIONS OF ALL CORPORATIONS WHICH OFFER OR PROVIDE TELECOMMUNICATIONS SERVICES, AND SHALL EXAMINE AND REPORT ON THE SAFETY AND SECURITY OF ALL FACILITIES, EQUIPMENT AND PROCEDURES OF SUCH CORPORATIONS AND MAKE RECOMMENDATIONS WITH RESPECT TO THE IMPROVEMENT OF THE SECURITY THEREOF.

2. The general business law is amended by adding a new article 37-B

to read as follows:
