AN ACT to amend the education law, in relation to capping the level of  
expenditures by school districts for central administration

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY,  
DO ENACT AS FOLLOWS:

- 1     Section 1. Section 2 of the education law is amended by adding a new  
2     subdivision 25 to read as follow:
- 3     25. CENTRAL ADMINISTRATION SERVICES. THE TERM "CENTRAL ADMINISTRATION  
4     SERVICES" MEANS ALL CENTRAL ADMINISTRATION SERVICES PROVIDED BY A  
5     COMMON, UNION FREE, CENTRAL SCHOOL DISTRICT, OR CENTRAL HIGH SCHOOL  
6     DISTRICT INCLUDING, BUT NOT LIMITED TO EXPENDITURES, SALARIES AND OTHER-  
7     WISE, FOR THE CHIEF SCHOOL OFFICER, THE SCHOOL PRINCIPAL, THE BUSINESS  
8     OFFICE, THE PURCHASING OFFICE, THE PERSONNEL OFFICE, THE RECORDS MANAGE-  
9     MENT OFFICE, PUBLIC INFORMATION AND SERVICES, FEES FOR FISCAL AGENTS,  
10    THE DISTRICT CLERK'S OFFICE, THE DISTRICT MEETING, AUDITING SERVICES,  
11    THE TREASURER'S OFFICE, THE TAX COLLECTOR'S OFFICE, LEGAL SERVICES, THE  
12    SCHOOL CENSUS, THE SUPPORT STAFF AND CLERICAL STAFF FOR SUCH SERVICES,  
13    OFFICERS AND OFFICES AND INDIRECT COSTS AND OTHER UNCLASSIFIED EXPENDI-  
14    TURES. "CENTRAL ADMINISTRATION SERVICES" SHALL NOT INCLUDE TEACHER SALA-  
15    RIES, TRANSPORTATION SERVICES OR CAPITAL COSTS.
- 16    S 2. The education law is amended by adding a new section 1510-a to  
17    read as follows:
- 18    S 1510-A. CENTRAL ADMINISTRATION SERVICES. NO COMMON, UNION FREE,  
19    CENTRAL SCHOOL DISTRICT, OR CENTRAL HIGH SCHOOL DISTRICT SHALL, IN ANY  
20    FISCAL YEAR, EXPEND MORE THAN THREE PERCENT OF ITS TOTAL BUDGET FOR  
21    CENTRAL ADMINISTRATION SERVICES, AS SUCH TERM IS DEFINED PURSUANT TO  
22    SUBDIVISION TWENTY-FIVE OF SECTION TWO OF THIS CHAPTER.
- 23    S 3. This act shall take effect immediately.
