AN ACT to amend the public health law, in relation to notifying hospital patients upon intake of reports of hospital-acquired infections

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 2819 of the public health law is amended by adding 2 a new subdivision 6-a to read as follows:

3 6-A. NO LATER THAN ONE HUNDRED EIGHTY DAYS AFTER THE ISSUANCE OF THE 4 REPORTS REQUIRED PURSUANT TO SUBPARAGRAPH (III) OF PARAGRAPH (C) OF 5 SECTION, SUBDIVISION FIVE OF THIS EACH GENERAL HOSPITAL SHALL BE 6 REQUIRED TO NOTIFY PATIENTS AS A COMPONENT OF PREBOOKING, INTAKE AND REGISTRATION OF THE HOSPITAL-ACQUIRED INFECTIONS, THAT WOULD BE REQUIRED 7 TO BE REPORTED TO THE DEPARTMENT PURSUANT TO THIS SECTION, THAT OCCURRED 8 9 IN THE HOSPITAL FOR THE PRIOR THIRTY DAY PERIOD. SUCH NOTIFICATION SHALL 10 BE UPDATED ON A DAILY BASIS AND SHALL BE ACCOMPLISHED THROUGH THE WHICH ARE EASILY UNDERSTANDABLE BY THE POSTING OF SIGNS, 11 CONSPICUOUS GENERAL PUBLIC, AND SHALL INCLUDE DIRECTIONS ON HOW TO OBTAIN ADDITIONAL 12 INFORMATION. TO THE DEGREE PRACTICABLE, THE FORMAT OF SUCH SIGNS 13 SHALL 14 BE CONSISTENT WITH THE FORMAT OF THE SUMMARY TABLE REQUIRED TO BE DEVEL-PURSUANT TO SUBDIVISION SIX OF 15 OPED THIS SECTION. UPON REOUEST THE HOSPITAL SHALL PROVIDE A PATIENT WITH AN INDIVIDUAL COPY OF THE INFORMA-16 17 TION CONTAINED ON SUCH SIGN. THE DEPARTMENT THROUGH REGULATION SHALL ESTABLISH PENALTIES APPLICABLE TO THE FIRST AND SUBSEQUENT VIOLATIONS OF 18 19 THE REQUIREMENT IMPOSED BY THIS SUBDIVISION.

20 S 2. This act shall take effect immediately.
