Introduced by Sen. LANZA -- read twice and ordered printed, and when printed to be committed to the Committee on Investigations and Government Operations

AN ACT to amend the tax law, in relation to exempting self-employment earnings of one million two hundred fifty thousand dollars or less from the metropolitan commuter transportation mobility tax

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph 2 of subsection (a) of section 801 of the tax
2 law, as amended by section 1 of part N of chapter 59 of the laws of
3 2012, is amended to read as follows:

4 (2) For individuals, the tax is imposed at a rate of thirty-four
5 hundredths (.34) percent of the net earnings from self-employment of
6 individuals that are attributable to the MCTD if such earnings attribut-
7 able to the MCTD exceed ONE MILLION TWO HUNDRED fifty thousand dollars
8 for the tax year.

9 S 2. This act shall take effect April 1, 2016.
