AN ACT to amend the real property law, in relation to training and continuing education requirements for home inspector licensing

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subparagraph (i) of paragraph (b) of subdivision 1 of  
2     section 444-e of the real property law, as amended by section 59 of part  
3     D of chapter 60 of the laws of 2012, is amended to read as follows:  
4     (i) have successfully completed a course of study of not less than  
5     [one] TWO hundred [forty] hours approved by the secretary, of which at  
6     least [forty] EIGHTY hours shall have been in the form of unpaid field  
7     based inspections in the presence of and under the direct supervision of  
8     a home inspector licensed by the state of New York or a professional  
9     engineer or architect regulated by the state of New York who oversees  
10    and takes full responsibility for the inspection and any report provided  
11    to a client; or  
12    S 2. Subdivision 1 of section 444-f of the real property law, as  
13    amended by section 60 of part D of chapter 60 of the laws of 2012, is  
14    amended to read as follows:  
15    1. Home inspector licenses and renewals thereof shall be issued for a  
16    period of two years, except that the secretary may, in order to stagger  
17    the expiration date thereof, provide that those licenses first issued or  
18    renewed after the effective date of this section shall expire or become  
19    void on a date fixed by the secretary, not sooner than six months nor  
20    later than twenty-nine months after the date of issue. No renewal of a  
21    license shall be issued unless the applicant has successfully completed  
22    [a course] AT LEAST THIRTY-TWO HOURS of continuing education approved by  
23    the secretary WITHIN THE TWO-YEAR PERIOD IMMEDIATELY PRECEDING SUCH  
24    RENEWAL, UP TO EIGHT HOURS OF WHICH MAY BE COMPLETED THROUGH ONLINE  
25    EDUCATION THAT ADHERES TO THE REQUIREMENTS SET FORTH BY THE SECRETARY.

1 S 3. Section 444-1 of the real property law, as amended by section 62  
2 of part D of chapter 60 of the laws of 2012, is amended to read as  
3 follows:

4 S 444-1. Duties of the secretary. 1. The secretary shall establish  
5 such rules and regulations as shall be necessary to implement the  
6 provisions of this article.

7 2. THE SECRETARY SHALL ESTABLISH RULES AND REGULATIONS PERTAINING TO  
8 THE NUMBER AND MANNER OF HOURS OF UNPAID FIELD-BASED TRAINING REQUIRED  
9 PURSUANT TO SUBPARAGRAPH (I) OF PARAGRAPH (B) OF SUBDIVISION ONE OF  
10 SECTION FOUR HUNDRED FORTY-FOUR-E OF THIS ARTICLE.

11 3. THE SECRETARY SHALL ESTABLISH RULES AND REGULATIONS PERTAINING TO  
12 THE NUMBER AND MANNER OF HOURS OF CONTINUING EDUCATION REQUIRED PURSUANT  
13 TO SUBDIVISION ONE OF SECTION FOUR HUNDRED FORTY-FOUR-F OF THIS ARTICLE.  
14 SUCH RULES AND REGULATIONS SHALL INCLUDE STANDARDS AND REQUIREMENTS FOR  
15 COMPUTER BASED DISTANCE LEARNING PROGRAMS.

16 S 4. This act shall take effect immediately.
