AN ACT to amend the public authorities law, in relation to the village of Nyack parking authority

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1622-c of the public authorities law, as added by
2 chapter 489 of the laws of 1991, is amended to read as follows:
3 S 1622-c. Village of Nyack parking authority. A board to be known as
4 "Village of Nyack parking authority" is hereby created. Such board shall
5 be a body corporate and politic, constituting a public benefit corpo-
6 ration, and its existence shall commence upon the appointment of the
7 members as herein provided. It shall consist of a chairman and four
8 other members, all of whom shall be appointed by the mayor with the
9 approval of the board of trustees of the village. The appointment of the
10 chairman shall be for a term of five years. Of the other members first
11 appointed, one shall be appointed for a period of one year, one for a
12 period of two years, one for a period of three years, one for a period
13 of four years. At the expiration of such terms, the terms of office of
14 their successors shall be five years. Each member shall continue to
15 serve until the appointment and qualification of his successor. Vacan-
16 cies in such board occurring otherwise than by the expiration of such
17 term, shall be filled for the unexpired term. The members of the board
18 shall choose from their number a vice-chairman and such other officers
19 deemed desirable by the board. The board of trustees may remove any
20 member of the board for inefficiency, neglect of duty or misconduct in
21 office, giving him a copy of the charges against him and an opportunity

1 of being heard in person, or by counsel, in his defense upon not less
2 than ten days' notice. The members of the board shall be entitled to no
3 compensation for their services but shall be entitled to reimbursement
4 for their actual and necessary expenses incurred in the performance of
5 their official duties. The powers of the authority shall be vested in
6 and exercised by a majority of the members of the board then in office.
7 Such board may delegate to one or more of its members or to its offi-
8 cers, agents and employees such powers and duties as it may deem proper.
9 Such board and its corporate existence shall continue only to the thir-
10 ty-first day of December, twenty hundred [fifteen] TWENTY-ONE, and ther-
11 eafter until all its liabilities and duties have been met and its bonds
12 and notes have been paid in full or such liabilities, bonds and notes
13 have otherwise been discharged. Upon its ceasing to exist, all its
14 rights and properties shall pass to the village.
15 S 2. This act shall take effect immediately.
