- AN ACT to amend the tax law, in relation to providing for the disposition of net collection from additional sales and compensating use taxes in the country of St. Lawrence

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The tax law is amended by adding a new section 1262-u to 2 read as follows:

3 DISPOSITION OF NET COLLECTIONS FROM THE ADDITIONAL RATE OF S 1262-U. 4 SALES AND COMPENSATING USE TAXES IN THE COUNTY OF ST. LAWRENCE. 5 NOTWITHSTANDING ANY CONTRARY PROVISION OF LAW, IF THE COUNTY OF ST. LAWRENCE IMPOSES THE ADDITIONAL ONE PERCENT RATE OF SALES AND COMPENSAT-6 7 ING USE TAXES AUTHORIZED BY SECTION TWELVE HUNDRED TEN OF THIS ARTICLE 8 THE PERIOD BEGINNING DECEMBER FIRST, TWO THOUSAND FOR ALL OR ANY OF 9 SIXTEEN AND ENDING NOVEMBER THIRTIETH, TWO THOUSAND SEVENTEEN, THE COUN-TY SHALL ALLOCATE (1) 6.437389 PERCENT OF THE NET COLLECTIONS 10 FROM THE ADDITIONAL ONE PERCENT TO THE CITY OF OGDENSBURG; (2) ONE-TENTH OF THE 11 12 NET COLLECTIONS FROM THE ADDITIONAL ONE PERCENT ΤO THETOWNS AND THE COUNTY ON THE BASIS OF THEIR RESPECTIVE POPULATIONS, 13 VILLAGES IN 14 DETERMINED IN ACCORDANCE WITH THE LATEST DECENNIAL FEDERAL CENSUS OR SPECIAL POPULATION CENSUS TAKEN PURSUANT TO SECTION TWENTY OF THE GENER-15 AL MUNICIPAL LAW COMPLETED AND PUBLISHED PRIOR TO THE END OF THE QUARTER 16 ALLOCATION IS MADE, AND (3) THE REMAINDER OF THE NET 17 WHICH THE FOR 18 COLLECTIONS FROM THE ADDITIONAL ONE PERCENT FOR COUNTY PURPOSES. THE NET 19 COLLECTIONS FROM THE ADDITIONAL RATE IMPOSED PURSUANT то THIS SECTION 20 SHALL BE DEPOSITED IN A SPECIAL FUND TO BE CREATED BY SUCH COUNTY SEPA-RATE AND APART FROM ANY OTHER FUNDS AND ACCOUNTS OF 21 THE COUNTY TO BE USED FOR THE PURPOSES DESCRIBED IN THIS SECTION. 22 23 S 2.
