AN ACT to amend chapter 56 of the laws of 2015, amending the education law relating to annual performance reviews of classroom teachers and building principals, in relation to the public comment period

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1 of subpart E of part EE of chapter 56 of the laws
2 of 2015, amending the education law relating to annual performance
3 reviews of classroom teachers and building principals, is amended to
4 read as follows:
5 Section 1. Authority of the commissioner. Notwithstanding any
6 provisions of section 3012-c of the education law to the contrary, the
7 commissioner of the state education department, is hereby authorized and
8 directed to, subject to the provisions of section 207 of the education
9 law, adopt regulations of the commissioner and guidelines no later than
10 [June 30] NOVEMBER 17, 2015, to implement a statewide annual teacher and
11 principal evaluation system in New York state pursuant to section 3012-d
12 of the education law, as added by this act, after consulting with
13 experts and practitioners in the fields of education, economics and
14 psychometrics and taking into consideration the parameters set forth in
15 the letter from the Chancellor of the Board of Regents and acting
16 commissioner dated December 31, 2014, to the New York State Director of
17 State Operations. SUCH COMMISSIONER SHALL EMPANEL A COMMITTEE OF SEVEN-
18 TEEN STAKEHOLDERS FROM THROUGHOUT THE STATE TO ADVISE THE COMMISSIONER
19 IN THE CREATION OF SUCH REGULATIONS AND GUIDELINES. MEMBERSHIP ON THE
20 COMMITTEE SHALL INCLUDE, BUT NOT BE LIMITED TO, REPRESENTATION FROM
21 PUBLIC SCHOOL ELEMENTARY AND SECONDARY-SCHOOL PARENTS, TEACHERS, PRINCI-
22 PALS, ADMINISTRATORS AND SUPERINTENDENTS, AS WELL AS RELATED NON-PROFIT
23 AND ADVOCACY ORGANIZATIONS AND BUSINESS COUNCILS. THIS ADVISORY COMMIT-
24 TEE SHALL ALSO INCLUDE CLASSROOM TEACHERS, EXPERIENCED EDUCATORS IN

1 TEST-CONTENT AREAS, AND TEACHERS OF STUDENTS WITH DISABILITIES AND
2 ENGLISH LANGUAGE LEARNERS. The commissioner shall also establish a proc-
3 ess to accept public comments and recommendations regarding the adoption
4 of regulations pursuant to section 3012-d of the education law and
5 consult in writing with the Secretary of the United States Department of
6 Education on weights, measures and ranking of evaluation categories and
7 subcomponents and shall release the response from the Secretary upon
