AN ACT to amend the general municipal law, in relation to burial of indigent veterans of the armed forces of the United States

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 148 of the general municipal law is amended by 2 adding a new subdivision 1-a to read as follows:

3 1-A. NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, IN THE CASE 4 OF AN INDIGENT VETERAN WHO DIED IN A COUNTY OR THE CITY OF NEW YORK 5 LEAVING NO FUNDS OR INSURANCE SUFFICIENT TO PAY FUNERAL AND BURIAL 6 EXPENSES OF SUCH VETERAN AND SUCH VETERAN HAS NO NEXT OF KIN OR PERSON 7 OF RECORD PREVIOUSLY DESIGNATED TO CONTROL HIS OR HER FINAL DISPOSITION 8 PURSUANT TO SECTION FOUR THOUSAND TWO HUNDRED ONE OF THE PUBLIC HEALTH 9 SUCH COUNTY OR THE CITY OF NEW YORK MAY REQUEST A CONGRESSIONAL LAW, 10 CHARTERED VETERANS' ORGANIZATION WITHIN THE COUNTY OR THE CITY OF NEW AT THE TIME OF DEATH, TO ENGAGE THE DECEDENT RESIDED 11 YORK WHERE THE12 SERVICES OF A FUNERAL FIRM TO CONDUCT THE FUNERAL AND BURIAL SERVICES. SUCH ORGANIZATION SHALL INCUR THE COSTS ASSOCIATED WITH SUCH SERVICES, 13 14 WHICH SHALL INCLUDE BUT NOT BE LIMITED TO, THE PURCHASE OF А SUITABLE 15 CONTAINER FOR BURIAL, THE FUNERAL DIRECTOR'S PRICES FOR MERCHANDISE AND SERVICES FURNISHED, COST OF A GRAVE SITE AND A MILITARY FUNERAL 16 SERVICE 17 AΤ THE CEMETERY TO WHICH SUCH BODY SHALL BE INTERRED. THE STATE SHALL REIMBURSE SUCH CONGRESSIONAL CHARTERED 18 VETERAN ORGANIZATION FOR SUCH FUNERAL AND BURIAL SERVICE EXPENSES FOR INDIGENT VETERANS, EXCEPT THOSE 19 EXPENSES PREVIOUSLY REIMBURSED PURSUANT TO SECTION ONE HUNDRED FORTY-ONE 20 21 OF THE SOCIAL SERVICES LAW OR ANY OTHER LAW OR THOSE EXPENSES REIMBURSA-BLE OR PAYABLE BY THE FEDERAL GOVERNMENT; PROVIDED HOWEVER, 22 THAT THE
