Introduced by Sen. AMEDORE -- read twice and ordered printed, and when printed to be committed to the Committee on Finance

AN ACT to amend the state finance law, in relation to the probable life of class B, class C, and class D buildings; and to amend the local finance law, in relation to the periods of probable usefulness of class B, class C, and class D buildings

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 2 and 3 of section 61 of the state finance law
2 are amended and a new subdivision 3-a is added to read as follows:
3 2. [Twenty] TWENTY-FIVE years. Class B buildings. Buildings, the outer
4 walls of which are constructed of brick, stone, concrete, metal, stucco,
5 FIRE-RESISTANT TREATED WOOD or other fire-resisting material, including
6 a building which is rebuilt or altered so that it, together with addi-
7 tions or vertical or other extensions or replacements, are fire-resist-
8 ing.
9 3. [Fifteen] TWENTY years. Class C buildings. Buildings that are
10 neither class A nor class B as defined in subdivisions one and two,
11 including any such building which is rebuilt or altered so that any
12 addition or vertical or other extension is not fire-proof or fire-re-
13 sisting, as thus defined.
14 3-A. FORTY YEARS. CLASS D BUILDINGS. BUILDINGS FOR WHICH A LIFE CYCLE
15 ASSESSMENT HAS BEEN PERFORMED AS PART OF THE DESIGN PROCESS AND WHICH
16 HAVE A REFERENCE SERVICE LIFE OF AT LEAST SIXTY YEARS, OR BUILDINGS FOR
17 WHICH THE STRUCTURAL MATERIALS WERE SELECTED USING THE GREEN BUILDING
18 CONSTRUCTION REQUIREMENTS ESTABLISHED PURSUANT TO ARTICLE FOUR-C OF THE
19 PUBLIC BUILDINGS LAW.
20 S 2. Clauses (b) and (c) of subdivision 11 of paragraph a of section
21 11.00 of the local finance law, as amended by section 3 of part A of
22 chapter 93 of the laws of 2002, are amended and a new clause (d) is
23 added to read as follows:

1 (b) Class "B" (fire-resistant) buildings. Buildings, the outer walls
2 of which are constructed of brick, stone, concrete, metal, stucco,
3 FIRE-RESISTANT TREATED WOOD or other fire-resisting material, twenty-
4 five years.

5 (c) Class "C" buildings. Buildings which are neither class "A" nor
6 class "B", as defined in items (a) and (b) above, including any such
7 building which is rebuilt or altered so that it, together with any addi-
8 tion or vertical or other extension, is not fire-proof or fire-resist-
9 ing, as thus defined, [fifteen] TWENTY years.

10 (D) CLASS "D" BUILDINGS. BUILDINGS FOR WHICH A LIFE CYCLE ASSESSMENT
11 HAS BEEN PERFORMED AS PART OF THE DESIGN PROCESS AND WHICH HAVE A REFER-
12 ENCE SERVICE LIFE OF AT LEAST SIXTY YEARS, OR BUILDINGS FOR WHICH THE
13 STRUCTURAL MATERIALS WERE SELECTED USING THE GREEN BUILDING CONSTRUCTION
14 REQUIREMENTS ESTABLISHED PURSUANT TO ARTICLE FOUR-C OF THE PUBLIC BUILD-
15 INGS LAW, FORTY YEARS.

16 S 3. This act shall take effect immediately.
