AN ACT to amend the not-for-profit corporation law, in relation to the acquisition and disposition of property by land banks

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Paragraph (a) of section 1608 of the not-for-profit corporation law, as added by chapter 257 of the laws of 2011, is amended to  
2     read as follows:

3     (a) The real property of a land bank and its income and operations are  
4     exempt from all taxation by the state of New York and by any of its  
5     political subdivisions. NOTWITHSTANDING ANY OTHER GENERAL, SPECIAL OR  
6     LOCAL LAW RELATING TO FEES OF CLERKS, NO CLERK SHALL CHARGE OR COLLECT A  
7     FEE FOR FILING, RECORDING OR INDEXING ANY PAPER, DOCUMENT, MAP OR  
8     PROCEEDING FILED, RECORDED OR INDEXED FOR A LAND BANK, OR AN OFFICER  
9     THEREOF ACTING IN AN OFFICIAL CAPACITY, NOR FOR FURNISHING A TRANSCRIPT,  
10    CERTIFICATION OR COPY OF ANY PAPER, DOCUMENT, MAP OR PROCEEDING TO BE  
11    USED FOR LAND BANK PURPOSES.

12    S 2. Section 1609 of the not-for-profit corporation law is amended by  
13    adding a new paragraph (a-1) to read as follows:

14    (A-1) THIS SECTION GOVERNING THE DISPOSITION OF PROPERTY BY LAND BANKS  
15    SHALL SUPERSEDE SECTION TWENTY-EIGHT HUNDRED NINETY-SEVEN OF THE PUBLIC  
16    AUTHORITIES LAW IN THE GOVERNANCE OF PROPERTY DISPOSITIONS BY LAND BANKS  
17    AND, AS SUCH, NOTWITHSTANDING ANY OTHER GENERAL, SPECIAL OR LOCAL LAW TO  
18    THE CONTRARY, SECTION TWENTY-EIGHT HUNDRED NINETY-SEVEN OF THE PUBLIC  
19    AUTHORITIES LAW SHALL NOT APPLY TO LAND BANKS.

20    S 3. This act shall take effect immediately.
