AN ACT to amend the vehicle and traffic law, in relation to compliance with the national driver register

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

l Section 1. The vehicle and traffic law is amended by adding a new section 504-a to read as follows:

- 504-A. COMPLIANCE WITH THE PROVISIONS OF THE NATIONAL DRIVER REGIS-THE COMMISSIONER SHALL ISSUE, NO LATER THAN 1. DECEMBER TWO THOUSAND FIFTEEN, TO ALL PERSONS WHO HAVE BEEN ISSUED THIRTY-FIRST, A DRIVER'S LICENSE PURSUANT TO THIS ARTICLE, A NEW DRIVER'S WHICH IS FULLY COMPLIANT WITH THE STATUTORY PROVISIONS OF CHAPTER 303 OF 49 OF THE UNITED STATES CODE. THE DRIVER'S LICENSES ISSUED PURSU-ANT TO THIS SUBDIVISION SHALL BE ISSUED AT NO ADDITIONAL COST TO THE COMMISSIONER MAY PROMULGATE RULES OR REGULATIONS SUCH LICENSEES. CONSISTENT WITH THIS SECTION AS MAY BE NECESSARY TO ACQUIRE THE DOCUMEN-TATION NEEDED TO COMPLY WITH THE NATIONAL DRIVER REGISTRY.
- 2. THE COMMISSIONER SHALL ISSUE, ON AND AFTER DECEMBER THIRTY-FIRST, TWO THOUSAND FIFTEEN, TO ALL PERSONS WHO ARE ELIGIBLE TO RECEIVE A NEW LICENSE OR RENEWAL THEREOF PURSUANT TO THIS ARTICLE, A DRIVER'S LICENSE WHICH IS FULLY COMPLIANT WITH THE STATUTORY PROVISIONS, AND ANY REGULATIONS PROMULGATED PURSUANT TO SUCH STATUTORY PROVISIONS, OF CHAPTER 303 OF TITLE 49 OF THE UNITED STATES CODE. THE DRIVER'S LICENSES AND RENEWALS THEREOF ISSUED PURSUANT TO THIS SUBDIVISION SHALL BE ISSUED AT NO ADDITIONAL COST TO ALL SUCH LICENSEES, OTHER THAN THE ISSUANCE AND RENEWAL FEE AUTHORIZED BY THIS CHAPTER.
- 3. THE COMMISSIONER SHALL FURTHER MAKE A REVIEW OF ALL APPLICABLE FEDERAL LAWS AND REGULATIONS CONCERNING THE ISSUANCE OF DRIVER'S LICENSES AND VEHICLE REGISTRATIONS, AND SHALL ISSUE A REPORT, ON OR BEFORE THE FIFTEENTH OF DECEMBER OF EACH YEAR, TO THE GOVERNOR, THE
